AN ORDINANCE AMENDING VARIOUS SECTIONS OF THE UTAH COUNTY ZONING ORDINANCE TO CHANGE THE EXISTING NAME OF "CITY- COUNTY HEALTH DEPARTMENT" TO "COUNTY HEALTH DEPARTMENT"

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF UTAH ORDAINS AS FOLLOWS:

Part I:

Utah County Zoning Ordinance, Sections 3-22, 3-51-D-8, 6-1-D-2, 6-2-D-7-k, 6-2-E-12(two references), 6-3-D-7-h, 6-3-E-11(two references), 6-4-D-7-k, 6-4-E-12(two references), 6-5-D-7-k, 6-5-E-13(two references), 6-6-D-7-k, and 6-6-E-12(two references), are amended to change each reference from "City-County Health Department" to "County Health Department"

Part II:

Insert pages reflecting the above amendments, including a title page which bears the enactment date of this ordinance, are hereby ordered to be filed in the three copies of the Utah County Zoning Ordinance which are on file with the Utah County Clerk-Auditor.

Part III:

If any of the sections, sentences, clauses or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdiction, such shall not affect or invalidate the remaining portion contained herein.

Part IV:

This ordinance shall take effect: 1) sixteen (16) days after it is passed, or 2) after it has been published, whichever date is later.
