

ORDINANCE NO. 2003_46

AN ORDINANCE AMENDING SECTION 5-8-B OF THE UTAH COUNTY ZONING ORDINANCE, NC-1 ZONE, TO ADD OFF HIGHWAY VEHICLE SALES AND REPAIR

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF UTAH ORDAINS AS FOLLOWS:

Part I:

Utah County Zoning Ordinance, Section 5-8-B is hereby amended to add a new sub-section 27 to read as follows:

27. Off Highway Vehicles (OHV) sales and repair.

Part II:

Insert pages reflecting the above amendments, including a title page which bears the enactment date of this ordinance, are hereby ordered to be filed in the three copies of the Utah County Zoning Ordinance which are on file with the Utah County Clerk-Auditor.

Part III:

If any of the sections, sentences, clause or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdictions, such shall not affect or invalidate the remaining portion contained herein.


Part IV:
