**AN ORDINANCE AMENDING THE UTAH COUNTY ZONING ORDINANCE
SECTIONS 6-4-E-13-b; 6-4-F-5; 6-5-E-14-b; 6-5-F-5; 6-6-E-13-a and 6-6-F-7 TO DELETE
THE REQUIREMENT FOR FIRE EQUIPMENT BOXES IN LARGE SCALE
DEVELOPMENTS**

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF UTAH
ORDAINS AS FOLLOWS:

PART I:

Sections 6-4-E-13-b, 6-5-E-14-b, and 6-6-E-13-a, requirements for fire equipment boxes in Mountain Home Developments, Recreational Resorts, and Mobile Home Parks shall be deleted and all paragraphs following to be re-designated in alphabetical order.

PART II:

Sections 6-4-F-5, 6-5-F-5, 6-6-F-7, shall be amended to read as follows:

Fuel breaks and fire hydrants.

PART III:

Insert pages reflecting the above amendments are hereby ordered to be filed in the three copies of the Official Utah County Zone Map on file with the Utah County Clerk.

PART IV:

This ordinance shall take effect: 1. fifteen (15) days after it is passed, or 2. after it has been published, whichever date is later.

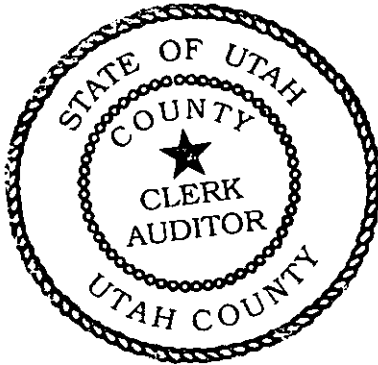
