**AN ORDINANCE AMENDING SECTION 5-8-B OF THE UTAH COUNTY ZONING  
ORDINANCE, PERMITTED USES, TO ALLOW FISH HATCHERIES  
AND THE RAISING OF FISH INDOORS IN THE NC-1 ZONE**

THE COUNTY LEGISLATIVE BODY OF UTAH COUNTY ORDAINS AS FOLLOWS:

**Part I:**

Utah County Zoning Ordinance, Section 5-9-B is hereby amended to add an additional paragraph 28 to read as follows:

28. Fish hatcheries and the raising of fish indoors.

**Part II:**

Insert pages reflecting the above amendments, including a title page which bears the enactment date of this ordinance, are hereby ordered to be filed in the three copies of the Utah County Zoning Ordinance which are on file with the Utah County Clerk-Auditor.

**Part III:**

If any of the sections, sentences, clause or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdictions, such shall not affect or invalidate the remaining portion contained herein.

**Part IV:**

This ordinance shall take effect: 1) fifteen (15) days after it is passed, or 2) after it has been published, whichever date is later.

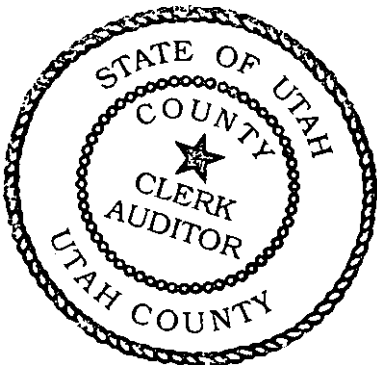
