

**AN ORDINANCE AMENDING SECTION 3-19-A, "LOCATION OF BUILDINGS AND PENS FOR FARM ANIMALS," OF THE UTAH COUNTY LAND USE ORDINANCE**

THE COUNTY LEGISLATIVE BODY OF UTAH COUNTY ORDAINS AS FOLLOWS:

**Part I:**

The Utah County Land Use Ordinance, Section 3-19-A, is hereby amended to read as follows:

**3-19: LOCATION OF BUILDINGS AND PENS CONTAINING FARM ANIMALS**

- A. No building, feed yard, corral, pen, or coop used for farm animals (specifically domestic livestock, poultry, or mink or other furbearers) shall be constructed closer than fifty (50) feet to an existing dwelling or vice versa.

**Part II:**

A copy of the Utah County Land Use Ordinance, as amended herein, is hereby ordered to be filed in the office of the Utah County Clerk/Auditor.

**Part III:**

If any of the sections, sentences, clauses or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdiction, such shall not affect or invalidate the remaining portion contained herein.

**Part IV:**

This ordinance shall become effective fifteen (15) days after its passage, and upon at least one (1) publication in a newspaper published in and having general circulation in Utah County.
