

AN ORDINANCE AMENDING SECTION 7-1, ZONING ADMINISTRATOR APPOINTED, OF THE UTAH COUNTY LAND USE ORDINANCE

THE COUNTY LEGISLATIVE BODY OF UTAH COUNTY ORDAINS AS FOLLOWS:

Part I:

The Utah County Land Use Ordinance, Section 7-1, is hereby amended in its entirety to read as follows:

7-1: ZONING ADMINISTRATOR APPOINTED

The Community Development Director, or his/her authorized agent, is designated as the Zoning Administrator, and is charged with the administration and enforcement of this Land Use Ordinance.

Part II:

The Utah County Land Use Ordinance, as amended herein, is hereby adopted in book form and a copy of said Utah County Land Use Ordinance is hereby ordered to be filed in the office of the Utah County Clerk/Auditor.

Part III:

If any of the sections, sentences, clauses or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdiction, such shall not affect or invalidate the remaining portion contained herein.

Part IV:

This ordinance shall become effective fifteen (15) days after its passage, and upon at least one (1) publication in a newspaper published in and having general circulation in Utah County.

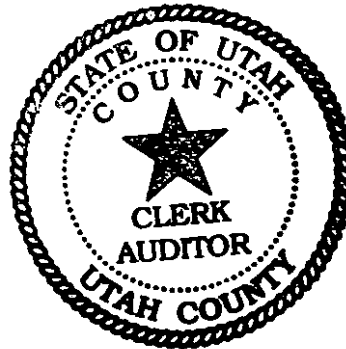
