

AN ORDINANCE AMENDING UTAH COUNTY LAND USE ORDINANCE SECTION 3-34 "TEMPORARY USES AND STRUCTURES," AMENDING SECTION 3-34-B-1(h), SMALL TEMPORARY EVENT, DISTANCE REQUIREMENT

THE COUNTY LEGISLATIVE BODY OF UTAH COUNTY ORDAINS AS FOLLOWS:

Part I:

The Utah County Land Use Ordinance, Section 3-34-B-1(h), is hereby amended to read as follows:

3-34-B

- h. No portion of the small temporary event may be located closer than 200 feet from any dwelling except the dwelling that exists on the parcel of the small temporary event.

Part II:

The Utah County Land Use Ordinance, as amended herein, is hereby adopted in book form and a copy of said Utah County Land Use Ordinance is hereby ordered to be filed in the office of the Utah County Clerk/Auditor.

Part III:

If any of the sections, sentences, clauses or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdiction, such shall not affect or invalidate the remaining portion contained herein.

Part IV:

This ordinance shall become effective fifteen (15) days after its passage, and upon at least one (1) publication in a newspaper published in and having general circulation in Utah County.

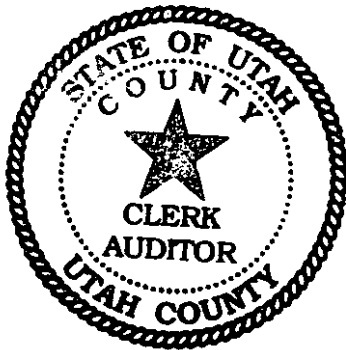
