

**AN ORDINANCE DELETING SECTION 2-2-B-96, DEFINITION OF "STRUCTURE OR FACILITY FOR HUMAN OCCUPANCY (OCCUPIED BY HUMANS)," UTAH COUNTY LAND USE ORDINANCE**

**THE COUNTY LEGISLATIVE BODY OF UTAH COUNTY ORDAINS AS FOLLOWS:**

**Part I:**

Utah County Land Use Ordinance, Section 2-2-B-96, definition of Structure or Facility for Human Occupancy (Occupied by Humans), is hereby deleted in its entirety.

**Part II:**

A copy of the Utah County Land Use Ordinance, as amended herein, is hereby ordered to be filed in the office of the Utah County Clerk/Auditor.

**Part III:**

If any of the sections, sentences, clause or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdiction, such shall not affect or invalidate the remaining portion contained herein.

**Part IV:**

This ordinance shall become effective fifteen (15) days after it is passed, and upon at least one (1) publication in a newspaper published in and having general circulation in Utah County.

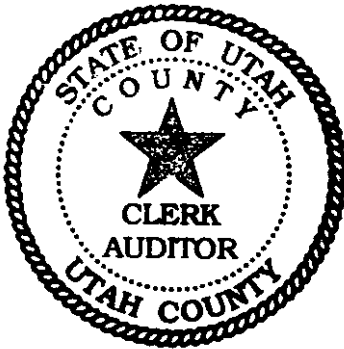
