ORDINANCE NO. 2013- 4

AN ORDINANCE ENACTING SECTION 2-2-B-17.5, DEFINITION OF COUNTY ENGINEER, AND SECTION 2-2-B-103, DEFINITION OF ZONING ADMINISTRATOR, OF THE UTAH COUNTY LAND USE ORDINANCE AND AMENDING SECTIONS OF THE UTAH COUNTY LAND USE ORDINANCE TO REPLACE VARIATIONS OF THE TERM "COMMUNITY DEVELOPMENT DIRECTOR" WITH THE TERM "ZONING ADMINISTRATOR" AND TO REPLACE VARIATIONS OF THE TERM "PUBLIC WORKS DIRECTOR" WITH THE TERM "COUNTY ENGINEER"

WHEREAS, the Utah County Planning Commission initiated a review of the Utah County Land Use Ordinance (UCLUO), dealing with enacting Section 2-2-B-17.5, definition of County Engineer, and Section 2-2-B-103, definition of Zoning Administrator, and amending sections of the Utah County Land Use Ordinance to replace variations of the term "Community Development Director" with the term "Zoning Administrator" and to replace variations of the term "Public Works Director" with the term "County Engineer"; and

WHEREAS, the Planning Commission addressed the proposed amendments to the Utah County Land Use Ordinance during the regularly scheduled meeting of the Planning Commission, scheduled and held a public hearing regarding the proposed amendments, and made a recommendation to the Board of County Commissioners regarding the proposed amendments; and

WHEREAS, the Board of County Commissioners has received and carefully reviewed the recommendation from the Planning Commission regarding the proposed amendments, and the minutes from the Utah County Planning Commission meeting and public hearing regarding the proposed amendments to the Utah County Land Use Ordinance; and

WHEREAS, the Board of County Commissioners has received and carefully reviewed the input, documents, and testimony from the public regarding the proposed amendments to the Utah County Land Use Ordinance; and

WHEREAS, the Board of County Commissioners finds that the proposed amendments to the Utah County Land Use Ordinance are in the best interest of the health, safety, and welfare of the citizens of Utah County, considering all factors.

NOW, THEREFORE, THE COUNTY LEGISLATIVE BODY OF UTAH COUNTY ORDAINS AS FOLLOWS:

Part I:

Section 2-2-B-18.5, List of Definitions, of the Utah County Land Use Ordinance is hereby enacted, to read as follows:

18.5 County Engineer

County Engineer shall mean the Utah County Public Works Director or any of his/her duly appointed designees.

Part II:

Section 2-2-B-103, List of Definitions, of the Utah County Land Use Ordinance is hereby enacted, to read as follows:

103. Zoning Administrator

Zoning Administrator shall mean the Utah County Associate Director of Community Development or any of his/her duly appointed designees.

Part III:

The Utah County Land Use Ordinance is hereby amended to replace all occurrences of the terms "Director of Public Works", "Utah County Public Works Director", "Utah County Public Works Department Director", "Public Works Director", and "County Public Works Director", with the term "County Engineer".

Part IV:

The Utah County Land Use Ordinance is hereby amended to replace all occurrences of the terms "Utah County Community Development Director", "Community Development Director", and "Planning Director", with the term "Zoning Administrator".

Part V:

A copy of the Utah County Land Use Ordinance, as amended herein, is hereby ordered to be filed in the office of the Utah County Clerk/Auditor.

Part VI:

If any of the sections, sentences, clauses or provisions of this ordinance shall for any reason be adjudged inapplicable or invalid by a court of competent jurisdiction, such shall not affect or invalidate the remaining portion contained herein.

Part VII:

This ordinance shall become effective fifteen (15) days after it is passed and upon at least one (1) publication in a newspaper published in and having general circulation in Utah County.


