

ORDINANCE NO. 2014-02

AN ORDINANCE OF THE COUNCIL OF THE TOWN OF VINEYARD, UTAH, AMENDING THE TOWN OF VINEYARD ZONING ORDINANCE, SECTION 303 RELATING TO THE COMPOSITION OF THE PLANNING COMMISSION AS SHOWN IN THE FILE.

WHEREAS, all due and proper notices of public hearings on this Ordinance held before the Town of Vineyard Planning Commission (the "Commission") and the Council of the Town of Vineyard (the "City Council") were given in the time, form, substance and manner provided by Utah Code; and

WHEREAS, the Commission held public hearings on this Ordinance on April 2, 2014; and

WHEREAS, the Commission recommended to the Town Council that this Ordinance be approved; and

WHEREAS, the Town Council held a public hearing on this Ordinance on April 23, 2014.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF VINEYARD as follows:

SECTION 1. That the Vineyard Town Zoning Ordinance Section 303 be amended as follows:

Section 303.2.1

The Commission shall consist of five (5) REGULAR members AND UP TO THREE (3) ALTERNATES.

Section 303.2.3

Members of the Commission shall be residents of the Town of Vineyard. No member of the Commission shall be an elected official ~~or employee of Vineyard.~~



SECTION 2. That the Mayor, the Town Clerk and the Town Attorney are hereby authorized and directed to execute all documents and take all steps necessary to carry out the purpose of this Ordinance.

SECTION 3. If any provision of this Ordinance is for any reason held by any court of competent jurisdiction to be unenforceable, such provision or portion hereof shall be deemed separate, distinct, and independent of all other provision and such holding shall not affect the validity of the remaining portions of this Ordinance.
