Ordinance No. 2024 – 20

**An Ordinance Re-Creating Section 8.19 of the Waukesha Municipal Code,
Regarding Massage Businesses**

The Common Council of the City of Waukesha do ordain as follows:

Section 1. Section 8.19 of the Waukesha Municipal Code, previously repealed and its number reserved, is hereby re-created to read in its entirety as follows:

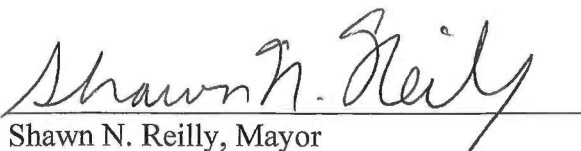
8.19 Massage Businesses.

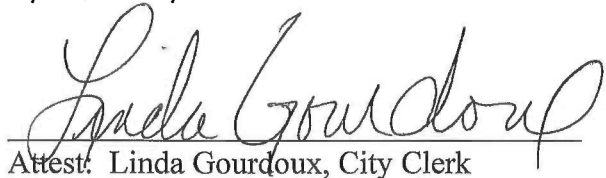
- (1) No individual shall engage in any activity for which a license is required under Wis. Stat. §460.02 unless that individual is licensed as required by Wis. Stat. §460.02.
- (2) No person shall employ or contract the services of an individual for which a license is required under Wis. Stat. §460.02 unless that individual is licensed as required by Wis. Stat. §460.02.
- (3) Violations of this section shall result in a forfeiture of not more than \$1,000.00 for each separate offense. Each day of a continued violation shall be a separate offense.

Section 2. All ordinances, or portions of ordinances, inconsistent with this ordinance are hereby repealed.

Section 3. This Ordinance shall be effective the day after its publication.
