

Ordinance O-22-40

ORDINANCE AMENDING SEC. 11.32.080 OF THE WAUWATOSA MUNICIPAL CODE FOR PARKING REGULATIONS ON GLENDALE AVENUE, EAST OF 100TH STREET, FOR MADISON ELEMENTARY

The Common Council of the City of Wauwatosa do ordain as follows:

Part I. The "Glendale Avenue - south side" portion of the "Schedule of streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(z)(ii) from the main entrance of Madison School to thirty feet west thereof"

"(h) from a point three hundred thirty-five feet east of N. 100th Street to a point five hundred ninety-five feet east of said 100th street"

Part II. The "Glendale Avenue - south side" portion of the "Schedule of streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(pp) from N. 100th Street to a point 214' feet east of said N. 100th Street"

"(pp) from N. 100th Street to a point 236' feet east of N. 100th Street to a point 270' east of said N. 100th Street"

"(rr) from a point 270' east of N. 100th Street to a point 748' of said N. 100th Street"

Part III. The schedule of "On-street handicapped parking areas" in Wauwatosa Code Section 11.32.490 is hereby amended by deleting the following:

2. On the east side of North 100th Street from a point twenty-five feet south of the centerline of the entrance sidewalk on the west side of the Madison Elementary School building"

Part IV. The schedule of "On-street handicapped parking areas" in Wauwatosa Code 11.32.490 is hereby amended by adding the following:

2. On the south side of Glendale Avenue from a point 214' feet east of N. 100th Street to a

point 236' east of said N. 100th Street

Part V. The "Glendale Avenue - north side" portion of the "Schedule of streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following:

"(a) from N. 100th Street to a point 113' feet east of said N. 100th Street"

Part VI. The "Glendale Avenue - north side" portion of the "Schedule of streets, and portions" subsection of the Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following:

"(a) from a point fifty feet east of N. 100th Street for an additional fifty feet east thereof"

Part VII. This ordinance shall take effect on and after its date of publication.

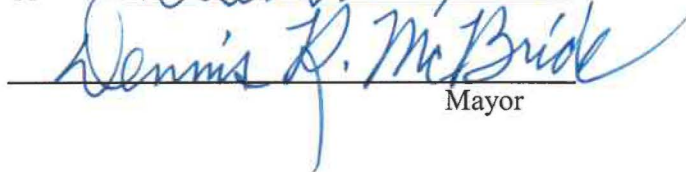
