

Ordinance O-22-33

ORDINANCE AMENDING SECTION 11.32.080 OF THE WAUWATOSA MUNICIPAL CODE
RELATIVE TO PARKING REGULATION MODIFICATIONS ON 97TH, 98TH, 99TH, 103RD AND
104TH STREETS BETWEEN BLUE MOUND ROAD AND WISCONSIN AVENUE

The Common Council of the City of Wauwatosa do ordain as follows:

Part I. The "North 97th Street - East Side" portion of the "Schedule of streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restriction is deleted):

"(a) from terminus at the south cul de sac near Blue Mound Road to the south corner of the 97th Street frontage road intersection"

Part II. The "North 97th Street - West Side" portion of the "Schedule of streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restrictions are deleted):

"(q) from the terminus at the cul de sac near Blue Mound Road to the North terminus at the cul de sac near Wisconsin Avenue"

Part III. The "North 98th Street - East Side" portion of the "Schedule of streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restrictions are deleted):

"(t)(q) from a point 140 feet north of Blue Mound Road to Wisconsin Avenue"

Part IV. The "North 98th Street - West Side" portion of the "Schedule of streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restrictions are deleted):

“(a) from Blue Mound Road to a point 60 feet north thereof

(ee) from a point 200 feet north of Blue Mound Road to Wisconsin Avenue”

Part V. The "99th Street - East Side" portion of the "schedule of streets, and portions" subsection of the Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restrictions are deleted):

“(a) from Blue Mound Road to a point 130 feet north thereof

(t)(q) from a point 130 feet north of Blue Mound Road to a point 260 feet north thereof

(a) from a point 260 feet north of Blue Mound Road to Wisconsin Avenue”

Part VI. The "99th Street - West Side" portion of the "schedule of streets, and portions" subsection of the Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restrictions are deleted):

“(a) from Blue Mound Road to a point 160 feet north thereof

(t) from a point 330 feet north of Blue Mound Road to Wisconsin Avenue”

Part VII. The "103rd Street - East Side" portion of the "schedule of streets, and portions" subsection of the Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restrictions are deleted):

“(a) from Blue Mound Road to a point 50 feet north thereof

(t) from a point 50 feet north of Blue Mound Road to Wisconsin Avenue”

Part VIII. The "103rd Street - West Side" portion of the "schedule of streets, and portions" subsection of the Wauwatosa Code Section 11.32.080 is hereby amended to read in its entirety as follows (current listed restrictions are deleted):

“(t)(q) from Blue Mound Road to Wisconsin Avenue”

Part IX. The "104th Street - East Side" portion of the "schedule of streets, and portions" subsection of the Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following provision:

“(q) from W. Blue Mound Road to W. Wisconsin Avenue”

Part X. This ordinance shall take effect on and after its date of publication.

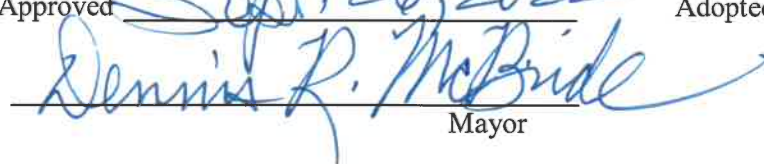
