

Ordinance O-21-27

ORDINANCE AMENDING SECTION 11.32.080 OF THE WAUWATOSA MUNICIPAL CODE REMOVING PARKING TO ADD BIKE LANES ON N. 68TH STREET BETWEEN HONEY CREEK PARKWAY AND WISCONSIN AVENUE

The Common Council of the City of Wauwatosa do hereby ordain as follows:

Part I. The "North 68th Street - east side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following subsections:

“(c) from W. Wisconsin Avenue to Cedar Street”

and

“(a) from 25 feet north of Aetna Court to 25 feet south of Aetna Court”

and

"(cc) from a point 148 feet south of West Cedar Street to a point 187 feet south of West Cedar Street"

and

"(a) from Honey Creek Parkway to the south lot line of 1262 N. 68th Street"

and

"(a) between the driveways on N. 68th Street near Colectivo Coffee, 6745 W. Wells Street and the residence to the south;

Part II. The "North 68th Street - east side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following subsections:

“(a) from Wisconsin Avenue to a point 175 feet north of Wisconsin Avenue”

and

“(c) from a point 175 feet north of Wisconsin Avenue to Aetna Court”

and

“(a) from Aetna Court to Honey Creek Parkway”

Part III. The "North 68th Street -west side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by deleting the following subsections:

"(c) from Terrace Court to Auburn Court"

and

"(a) from 40 feet south of Cedar Street to 40 feet north of Cedar Street"

and

"(d) from W. Wells Street to Cedar Street"

and

"(a) from Honey Creek Parkway to the south lot line of 1245 N. 68th Street"

Part IV. The "North 68th Street - west side" portion of the "Schedule of Streets, and portions" subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the following subsections:

"(a) from Wisconsin Avenue to a point 190 feet north of Wisconsin Avenue"

and

"(c) from a point 190 feet north of Wisconsin Avenue to Aetna Court"

and

"(a) from Aetna Court to Honey Creek Parkway"

Part V. NON-CODIFIED PROVISIONS: Dedicated bicycle lanes are to be added from Honey Creek Parkway to Aetna Court, and shared bicycle lane markings ("sharrows") are to be added from Aetna Court to Wisconsin Avenue for both Southbound and Northbound travel

Part VI. This ordinance shall become effective on and after its dates of passage and publication and following completion of construction to create new bike lane infrastructure and pavement markings.

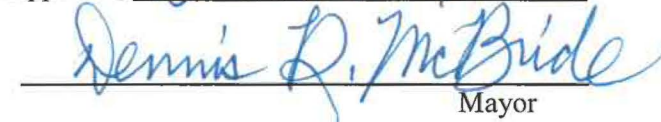
