

Ordinance O-21-19

ORDINANCE AMENDING SECTION 11.32.080 AND 11.32.490 OF THE WAUWATOSA MUNICIPAL CODE TO CREATE PARKING ZONES BY WAUWATOSA EAST HIGH SCHOOL

The Common Council of the City of Wauwatosa do ordain as follows:

Part I. The “North 73rd Street - East side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by modifying the subsection that reads as follows:

“(m) from W. Milwaukee Avenue to W. Lloyd Street”

to read as follows:

“(m) from 50 feet north of Milwaukee Avenue to W. Lloyd Street”

Part II. The “North 73rd Street - East side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(jj) from Milwaukee Avenue to 50 feet north of Milwaukee Avenue”

Part III. The “North 73rd Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as follows:

“(m) from W. Milwaukee Avenue to W. Lloyd Street

Part IV. The “North 73rd Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as

follows:

“(a) from a point 95 feet north of Milwaukee Avenue for a distance of 37 feet north thereof”

Part V. The “North 73rd Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(jj) from Milwaukee Ave. to 50 feet north of Milwaukee Ave.”

Part VI. The “North 74th Street - East side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as follows:

“(c) from Hillcrest Drive to a point 350 feet south of Hillcrest Drive”

Part VII. The “North 74th Street - East side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as follows:

“(c) from Milwaukee Avenue to a point 350 feet south of Hillcrest Drive”

Part VIII. The “North 74th Street - East side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the subsection which reads as follows:

“(a) Milwaukee Ave. to Lloyd St.

Part IX. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as follows:

“(z)(ss) from a point 32 feet north of Milwaukee Avenue to a point 180 feet north”

Part X. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as follows:

“(a)(z) from a point 250 feet north of Milwaukee Avenue to a point 300 feet north”

Part XI. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as follows:

“(p) from a point 300 feet south of Hillcrest Drive to Hillcrest Drive”

Part XII. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection which reads as follows:

“(m) from Hillcrest Drive to Kenwood Avenue”

Part XIII. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(m) from Hillcrest Drive to a point of 130 feet north thereof”

Part XIV. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(m) from a point 125 feet south of Hillcrest Drive to a point 55 feet south thereof”

Part XV. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(a)(z) from 30 feet north of Milwaukee Ave. to a point 180 feet north thereof”

Part XVI. The “North 74th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(a) from Milwaukee Ave. to a point 30 feet north thereof”

Part XVII. The “North 75th Street - East side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(m) from Hillcrest Drive to cul-de-sac”

Part XVIII. The “North 75th Street - East side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(a) in cul-de-sac”

Part XIX. The “North 75th Street - West side” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding a subsection which reads as follows:

“(a) in cul-de-sac

Part XX. The “Alice Street - both sides” portion of the “Schedule of streets, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the portion which reads “Alice Street - both sides” and the restriction thereunder, and creating separate portions called “Alice Street - East side” and “Alice Street - West side”

Part XXI. The “Alice Street - East side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the subsection that reads as follows:

“(m) from Milwaukee Avenue, around the cul-de-sac, to the north side of the driveway to 1443 Alice Street”

Part XXII. The “Church Street - East side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by modifying the subsection that reads as follows:

“(m) from Menomonee River Parkway to Warren Avenue”

To read as follows:

“(m) from Menomonee River Parkway to Milwaukee Avenue”

Part XXIII. The “Hillcrest Drive - South side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(m) from N. 72nd Street to N. 73rd Street.”

Part XXIV. The “Hillcrest Drive - South side” portion of the “Schedule of street, and portions”

subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(a) from N. 73rd Street to N. 74th Street”

Part XXV. The “Hillcrest Drive - South side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(rr) from N. 74th Street to a point 62 feet east of N. 75th Street”

Part XXVI. The “Hillcrest Drive - South side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(a) from 62 feet east of N. 75th Street to a point 132 feet west of N. 75th Street”

Part XXVII. The “Hillcrest Drive - South side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(rr) from a point 132 feet west of N. 75th Street to Wauwatosa Avenue”

Part XXVIII. The “Hillcrest Drive - North side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(m) from N. 72nd Street to N. 74th Street”

Part XXIX. The “Hillcrest Drive - North side” portion of the “Schedule of street, and portions”

subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(m) from N. 74th Street to Wauwatosa Avenue”

Part XXX. The “Hillcrest Drive - North side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the subsection that reads as follows:

“(a) from 72nd street to 74th street”

Part XXXI. The “Hillcrest Drive - North side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the subsection that reads as follows:

“(m) from 74th street to 150 feet west of 74th street”

Part XXXII. The “Hillcrest Drive - North side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by adding the subsection that reads as follows:

“(a) from 150 feet west of 74th street to Wauwatosa Ave”

Part XXXIII. The “Underwood Avenue - East side” portion of the “Schedule of street, and portions” subsection of Wauwatosa Code Section 11.32.080 is hereby amended by removing the subsection that reads as follows:

“(h) from Hillcrest Drive to Woodland Avenue”

Part XXXIV. Subsection of Wauwatosa Code Section 11.32.490 is hereby amended by adding a new subsection that reads as follows:

“11. 75th Street- (West side) Hillcrest to cul-de-sac”

Part XXXV. This ordinance shall take effect on and after its date of publication.
