RESOLUTION TO AMEND FEE SCHEDULE - PARKING PERMIT FEES

WHEREAS, It is more cost-effective to administer the parking permit program by selling permits online rather than in person; and

WHEREAS, the City can charge a reduced parking permit fee for online purchases due to the lower cost to provide that service;

NOW THEREFORE, be it resolved by the Council of the City Of West Allis, in the State of Wisconsin, as follows:

SECTION 1: **AMENDMENT** “Police” of the City Of West Allis Fee Schedule is hereby *amended* as follows:

- Permits. The police chief shall collect the following permit fees as applicable.

- Service Fees. The police chief shall collect the following service fees as applicable.


