**RESOLUTION AMENDING FEE SCHEDULE TO ADD PAVILION RENTAL FEE AND
ALIGN WITH FEES CREATED OR IMPACTED BY REPEALING AND RECREATING
CH. 7 OF MUNICIPAL CODE**

WHEREAS, the common council repealed and recreated Chapter 7 of the municipal code within O-2025-0028; and

WHEREAS, the change in the municipal code requires changes to the fee schedule to align with the code;


