**RESOLUTION TO UPDATE COMMERCIAL BUILDING AND PLUMBING PLAN
REVIEW FEE SCHEDULES**

WHEREAS, the City may set fees for commercial building and plumbing plan review fees and remit the amounts specified by Wis. Adm. Code SPS Table 302.31-3 to the state;

NOW THEREFORE, be it resolved by the Common Council of the City Of West Allis, in the State of Wisconsin, as follows:

SECTION 1: **AMENDMENT** “Commercial” of the City Of West Allis Fee Schedule is hereby *amended* as follows:

AMENDMENT

Commercial

1. State-Authorized Fees. The code enforcement director may charge fees for any commercial building to the extent authorized by state law⁻.
2. Administrative Fees. The code enforcement director may charge the following administrative fees related to any commercial building or project.

3. Permits. The code enforcement director may charge the following permit fees for any commercial building.

4. Plan Review. The code enforcement director may charge fees for any commercial building plan review in accordance with ~~Table Wis. Adm. Code~~ SPS 302.31, ~~except-2, Wis. Adm. Code. In addition~~, the code enforcement director may charge the following plan review fees for any commercial building. Fees relating to the submittal of all building plans, heating, ventilating and air conditioning (HVAC) plans, and fire protection system plans shall be computed on the basis of the total gross square footage of each building or affected area.

SECTION 2: **AMENDMENT** “Plumbing-” of the City Of West Allis Fee Schedule is hereby *amended* as follows:

AMENDMENT

Plumbing-

1. Permit Fees. For any of the work listed below, the code enforcement director may charge a fee for a plumbing permit to perform such work. Unless otherwise stated in the table, the minimum fee for a plumbing permit is \$100.00 for a one- or two-family dwelling and \$125.00 for any other building, except the minimum fee for any new construction shall be \$175.00. Any fee based on lineal feet is not prorated and shall rounded up for any fractional lengths.

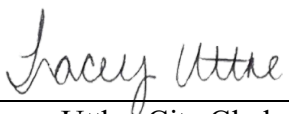

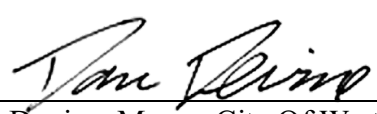
