ORDINANCE O-2020-0018**

**ORDINANCE TO AUTHORIZE CITY CLERK TO REDUCE OR INCREASE
NUMBER OF ELECTION OFFICIALS AT POLLING PLACES**

AMENDING SECTION 2.08

WHEREAS, it is in the public interest to staff polling places with the proper number of election officials who can provide excellent service; and

WHEREAS, it is in the public interest to ensure an efficient use of city resources by only staffing a polling site with the number of election officials necessary; and

WHEREAS, Wis. Stat. 7.30 and 7.32 empower the common council to authorize the city clerk to increase or decrease the number of election inspectors from the default of 7 to as few as 3 or as many as necessary;

NOW THEREFORE, the common council of the City of West Allis do ordain as follows:

SECTION 1: **AMENDMENT** “2.08 Elections And Officials” of the City Of West Allis Municipal Code is hereby *amended* as follows:

A M E N D M E N T

2.08 Elections And Officials

1. The city clerk may select alternate officials in a number sufficient to maintain adequate staffing of polling places on election day.
2. The city clerk may select 2 or more sets of election officials to work at different times on election day and may establish different working hours for different officials assigned to the same polling place.
3. The city clerk may appoint 3, 5, or 7 inspectors to each polling place and may appoint an additional inspector to serve as a greeter. The city clerk may appoint additional inspectors in compliance with Wis. Stat. 7.30.

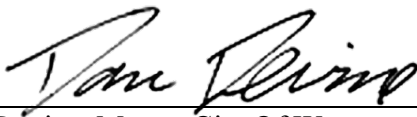
SECTION 2: **EFFECTIVE DATE** This Ordinance shall be in full force and effect after the required approval and publication according to law.

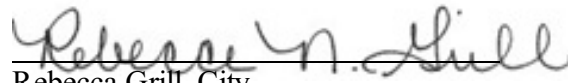
