

**CITY OF WEST ALLIS
ORDINANCE O-2021-0088**

**ORDINANCE TO PROHIBIT CERTAIN INTERACTIONS BETWEEN DRIVERS
AND PEDESTRIANS**

CREATING SECTION 10.24

WHEREAS, it is dangerous for a pedestrian to approach a vehicle in a traffic lane while the vehicle is being operated on a high volume street; and

WHEREAS, it is dangerous for a vehicle operator to decelerate, stop, or stand in a traffic lane to interact with pedestrians on a high volume street; and

WHEREAS, pedestrians and vehicles should interact on the street only when it can be done safely or is necessary to avoid greater harm;

NOW THEREFORE, the common council of the City of West Allis do ordain as follows:

SECTION 1: **ADOPTION** “10.24 Unsafe Pedestrian Interaction” of the City Of West Allis Municipal Code is hereby *added* as follows:

ADOPTION

10.24 Unsafe Pedestrian Interaction*(Added)*

1. No person may approach any vehicle on South 108th Street or West Oklahoma Avenue unless at least one of the following applies:
 - a. The vehicle is legally parked.
 - b. The vehicle is a public passenger vehicle.
 - c. The person is engaged in law enforcement or rescue activities.
 - d. The person is providing assistance to an injured or disabled vehicle or person.
 - e. The person is engaged in highway maintenance.
 - f. The person is an appointed school crossing guard.
2. No operator of a vehicle may slow, stop, or stand on South 108th Street or West Oklahoma Avenue to interact with a person who is violating sub. (1).
3. Penalty. Any person who violates this section shall forfeit not less than \$25 nor more than \$500.

SECTION 2: **EFFECTIVE DATE** This Ordinance shall be in full force and effect on and after the required approval and publication according to law.

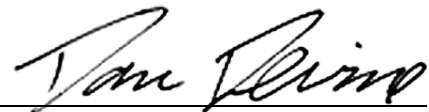
