

**CITY OF WEST ALLIS
ORDINANCE O-2024-0051**

**ORDINANCE TO ENACT NO PARKING RESTRICTIONS AT CERTAIN
LOCATIONS ON BOTH SIDES OF THE 11700 BLOCK OF W. CLEVELAND AVE.**

AMENDING SECTION 10.10

WHEREAS, Wis. Stat. 349.13(1e)(a) allows the City to prohibit, limit the time of or otherwise restrict the stopping, standing or parking of vehicles beyond the prohibitions, limitations or restrictions imposed by Wis. Stat. Ch. 346;

NOW THEREFORE, the common council of the City of West Allis do ordain as follows:

The north side of West Cleveland Avenue, from 135' west of the centerline of South 117th Street to 112' east of the centerline of South 117th Street, shall be "No Parking."

The south side of West Cleveland Avenue, from 263' west of the centerline of South 117th Street to 554' east of the centerline of South 117th Street, shall be "No Parking."

SECTION 1: **EFFECTIVE DATE** This Ordinance shall be in full force and effect on and after the required approval and publication according to law.

SECTION 2: **AUTHORIZATION** The director of public works is authorized to install or remove official traffic signs, pavement markings, or parking meters indicating any particular prohibition, limitation, or restriction to effectuate this ordinance.

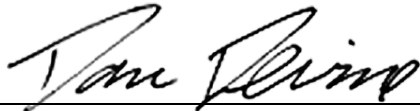
