An Ordinance Amending Chapter 90, Section 90.101 (b) of the Municipal
Code Entitled "Control of Noxious Weeds"

The Village Board of the Village of Weston, Marathon County, Wisconsin, do ordain as follows:

SECTION 1: Section 90.101 of the Municipal Code of the Village of Weston entitled "Control of noxious weeds" is hereby repealed and the same is recreated in the manner and form made a part hereof as if fully set forth herein at length as follows:


(Section 94.152) *Control of weeds, grasses, brush*

(b) No person owning property within the village shall permit to grow or pollinate upon his premises any weeds, grasses or brush that causes or produces or exhales unpleasant or noxious odors or may conceal filthy deposits or provide a place for the accumulation of trash or litter. In addition, the existence of noxious weeds upon any property within the village is prohibited. Every person shall destroy all noxious weeds on all lands which he shall own, occupy or control. The person having immediate charge of any public lands shall destroy all noxious weeds on such lands, which means the complete killing of weeds or the killing of weed plants above the surface of the ground **exceeding one-foot in height** by use of chemicals, cutting, tillage, cropping system, pasturing livestock or any or all of these in effective combination at such time and in such manner as will effectively prevent such plants from maturing to the bloom or flower stage.


SECTION 2: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: This ordinance shall be in full force and effect from and after its passage and publication.
