SECTION 1: Section 90.101 of the Municipal Code of the Village of Weston entitled "Control of noxious weeds" is hereby repealed and the same is recreated in the manner and form made a part hereof as if fully set forth herein at length as follows:

(Section 94.152) Control of weeds, grasses, brush

(c) It shall be the duty of the weed commissioner to enforce this section; and if any person shall fail to comply with this section, the commissioner shall, after ten days' written notice to the owner, cause the premises to be **mowed and** cleared of noxious weeds **and grasses** and report the cost in writing to the village clerk/treasurer in the manner provided in Wis. Stats. § 66.98. Such charge shall be spread on the tax roll as a special tax to be collected in the manner as other taxes unless such lands are exempt from taxation.

SECTION 2: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: This ordinance shall be in full force and effect from and after its passage and publication.
