EXIT INFORMATION and

FORMER EMPLOYEE Guide

The below information applies to Team Members at Goodwill of Central and Northern Arizona and Goodwill Industries of Monocacy Valley (together, the "Company"). This information is subject to change at any time, with or without notice. This information is also subject to change in accordance with applicable local, state or federal laws.

FINAL PAYCHECK

If you normally receive your pay check by direct deposit or pay card, your funds will be deposited into the account we have on file. If you do not have a direct deposit or a pay card on file, a live manual check will be mailed to your home address that is on file. If your address has changed please contact Human Resources immediately at 1-833-624-0920 to ensure the check is mailed to the correct address.

PROPERTY RETURN

You are required to return any Company property you may have in your possession, such as your identification badge, keys, cell phone, pager, tools, uniforms, computer equipment, files, etc.

W-2 FORM

Your W-2 (year-end tax record) will be mailed within Internal Revenue Service guidelines to the address on file with Human Resources. If your address has changed please contact Human Resources immediately at 1-833-624-0920. W-2 forms are also available through ADP iPay for the year 2020 and prior, and Workday for the year 2021 and after.

VERIFICATION OF EMPLOYMENT

Please visit The Work Number at www.theworknumber.com or call 1-800-367-5690. To request verification of employment. The employer code is 26043. You may also send a direct request by email to HRSupport@goodwillaz.org or via fax at (602) 535-4335. Make sure to include the "last four of your Social Security Number and date of birth for identity verification purposes.

INSURANCE PREMIUMS

Insurance premiums will be deducted from your last check for any plans you are currently enrolled in.

MEDICAL BENEFITS

If you are enrolled in medical benefits, your coverage will end on the last day of the month in which you were terminated.

MEDICAL, DENTAL, VISON AND HEALTH CARE SPENDING ACCOUNT

In accordance with the Consolidated Omnibus Reconciliation Act of 1985 (COBRA), you and your covered dependents have the option to continue your medical, dental, vision and/or health care spending account coverage for up to 18 months beyond your group coverage ending date. Coverage is eligible for up to 29 months if the covered person is disabled, as defined by Social Security Administration or becomes disabled at any time during the first 60 days of your COBRA eligibility period. You will be mailed a notification letter and application to the address on file in Human Resources from our third-party administrator, WEX. If you have any questions, you may contact WEX at 1-866-451-3399.

EMPLOYEE AND DEPENDENT LIFE

You may be eligible to convert your group life insurance to individual policies. You must apply for the conversion and pay the first premium within 31 days after termination. Please contact the Life Insurance Carrier, UNUM, at 1-800-421-0344 to initiate the conversion request.

CERTIFICATE OF CREDITABLE COVERAGE

In accordance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA), you will be mailed, with your COBRA notice from WEX, a Certificate of Creditable Coverage, which verifies the period of time you and your enrolled dependents were covered. You may need to present this certificate to a future employer in order to obtain credit toward its health plan's pre-existing condition exclusion.

RETIREMENT PLAN

If you are currently participating in the Company retirement plan, within 4-6 weeks of your termination date, you will receive a packet from The Principal outlining your options. Areas that will be addressed are distribution options, tax consequences and penalties, if any, that you will have depending on the decision you make for your monies.

TRANSFER

If you are transferring to another Goodwill, certain benefits may be transferable. Contact the Human Resources Department of the division in which you are transferring to determine which benefits are transferable.

REINSTATEMENT

Should you return to employment with the Company, certain benefits may be eligible for reinstatement. Contact Human Resources at 1-833-624-0920 for more information.





You will need the following items to complete your registration:


- Your social security number



- Click on Register Now




2. Enter the registration code: Goodwilla-2626 (This is case-sensitive.)




- 3. A new screen will appear, verifying the Company registration.

- 5. A new screen will appear, confirming your name. Click on **REGISTER NOW**.




- 6. The next screen will complete your registration.

 - Click on the "I authorize...." box.






- E. Click on the **REGISTER NOW** button at bottom of the screen.






7. Click on **IPAYSTATEMENTS** button. This will take you to the iPay login screen.
