

Comprehensive Multimodal Corridor Plans (CMCP)

CMCPs turn the vision and transportation priorities of the SANDAG 2021 Regional Plan into reality by developing corridor-specific projects and programs.

Project Overview

CMCPs are data-driven plans to reduce vehicle miles traveled and greenhouse gas emissions, identify mobility solutions, and preserve community character while creating opportunities for neighborhood enhancement projects.

SANDAG and Caltrans are evaluating travel modes and transportation facilities in each defined corridor, including highways and freeways, parallel and connecting roadways, pathways, bikeways, and transit options (local bus, *Rapid* bus, commuter rail, light rail, intercity rail, etc.).

The plans propose solutions and recommend projects to build more efficient transportation networks, support climate action initiatives, and improve access for residents, commuters, visitors, and goods movement.

CMCPs help SANDAG and Caltrans meet local, regional, and statewide goals for achieving a safe, sustainable, and effective transportation system for the San Diego region. Completing them will help the San Diego region compete for local, state, and federal funds, including Senate Bill 1, the Road Repair and Accountability Act of 2017.

Efforts Underway

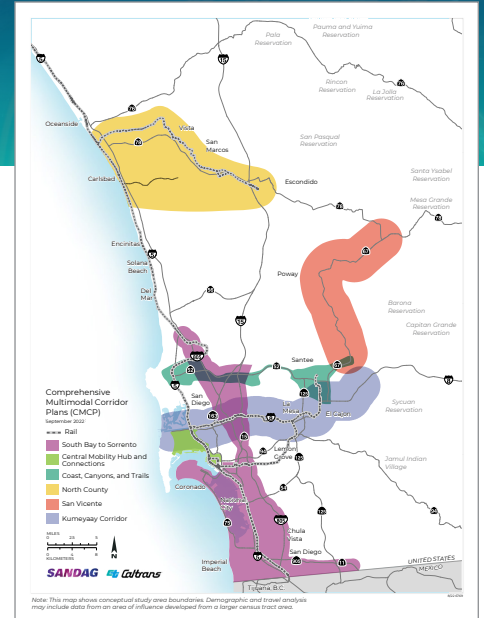
SANDAG and Caltrans are currently developing six CMCPs in coordination with community and agency partners, the County of San Diego, and local city governments.

- » Central Mobility Hub and Connections
- » Coast, Canyons, and Trails – SR 52
- » North County – SPRINTER/Palomar Airport Road/SR 78/SR 76
- » San Vicente – SR 67
- » South Bay to Sorrento – Purple Line/I-805/Blue Line/I-5 South
- » Kumeyaay Corridor – I-8

Additional corridors will be studied in future CMCPs within the next five years to inform the next Regional Plan.

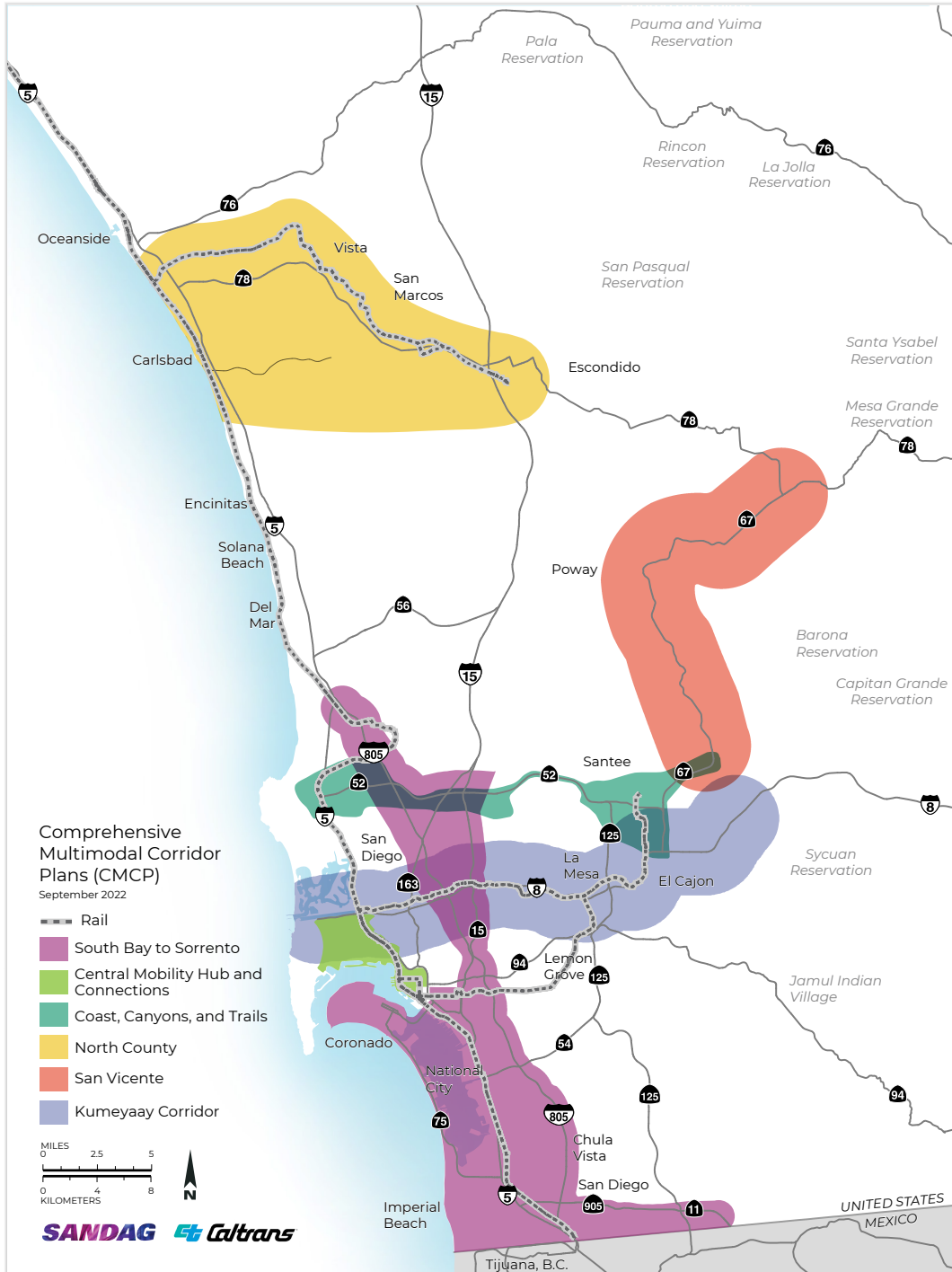
