Measurements:

Parakeet Party Cardstock: 11" x 4-1/4" scored and folded at 5-1/2"

Basic Black Cardstock: 5-1/4" x 4"
Basic White Cardstock: 4" x 2-1/2"

• DSP: 3-3/4" x 2"

Instructions:

- 1. Run Basic White Cardstock thru Cut & Emboss Machine with Country Corners die. Stamp rabbit using Tuxedo Black ink. Stamp greeting with Parakeet Party ink. Color eyes with Light Balmy Blue Blends Marker.
- 2. Layer DSP to Basic Black Cardstock panel with Seal. Layer panel to card front with Seal. Place a tiny dot of Liquid Glue at either end of DSP and press 3-3/4" length of faux leather trim into it. Allow to dry before proceeding.
- 3. Adhere die-cut to card front with Stampin' Dimensionals at top and bottom. Scatter 3 of the Lemon Lime Twist dots across card front as shown.
