NASPO VALUEPOINT COOPERATIVE PURCHASING PROGRAM

Administered by the State of Idaho (hereinafter "Lead State")

(hereinafter "Contractor")

And

State of Arkansas (SP-16-0221)
(hereinafter "Participating State")

1. Scope: This Participating Addendum (PADD) covers the Laboratory Equipment and Supplies contract led by the State of Idaho (Master Agreement No. MA16000234-2) for use by state agencies and other entities located in the Participating **State of Arkansas**, as provided below.

2. Participation: Use of NASPO ValuePoint cooperative contracts by agencies, political subdivisions and other entities authorized by an individual state's statutes to use **State of Arkansas** contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

3. Participating State Modifications or Additions to Master Agreement:

Payments shall be submitted to the contractor at the address shown on the invoice. Payment shall be tendered to the contractor within thirty (30) days of the date of the invoice. After the sixtieth (60) day from the date of the invoice unless mutually agreed to, interest shall be paid on the unpaid balance due to the contractor at a rate of one (1) percent per month in accordance with Arkansas Code Annotated § 19-11-224. The procuring agency shall make a good faith effort to pay within thirty (30) days after date of invoice.

Records relevant to Purchasing Entity transactions shall be subject to examination by appropriate government authorities for a period of five (5) years from the date of acceptance of the purchase order.

Reports shall be listed by state location, name of ordering entity, quantity purchased, unit price, and the total dollar amount sold.

Usage reports shall be delivered to the State of Arkansas, Office of State Procurement, 1509 West 7th Street, Little Rock, Arkansas 72201 (Attention: Judy Shirley) within thirty (30) calendar days upon completion of performance quarterly periods cited in the paragraph below. Reports may also be emailed to: Judy Shirley, Statewide Procurement Specialist, at judy.shirley@dfa.arkansas.gov.

Contract quarterly report periods shall be:

January 1 through March 31	due April 30
April 1 through June 30	due July 30
July 1 through September 30	due October 30
October 1 through December 31	due January 31

The State of Arkansas recognizes all Addendums attached to the original contract and enforced by the State of Idaho.

This agreement shall be governed by the laws of the State of Arkansas.

Notwithstanding any provisions in the Master Agreement to the contrary, the following shall apply to this PADD:

Orders: Any Order placed by a Participating Entity or Purchasing Entity for a Product and/or Service available from this Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions) of the Master Agreement unless the parties to the Order agree in writing that another contract or agreement applies to such Order. All orders issued by purchasing entities within the **State of Arkansas** must include the Participating State contract number: **SP-16-0221** as well as the Lead State Master Agreement No. **MA16000234-2**.

8. Entire Agreement: This PADD and the Master Agreement No. MA16000234-2, together with its exhibits, set forth the entire agreement between the parties with respect to the subject matter of all previous communications, representations or agreements, whether oral or written. The terms and conditions of this PADD shall prevail and govern in the case of any inconsistency or conflict with the terms and conditions of the Master Agreement, as to the Participating State, and shall otherwise have no impact on the Master Agreement and its exhibits.
