The State is not liable for the obligations of any local government which joins or uses this or any contract resulting from this Participating Addendum.
2. **REQUISITIONS:** All State agencies requisitions over \$5000.00 will be processed by and through the Nevada State Purchasing Division and a purchase order issued, as needed, at the contracted price(s). Local governments as defined in NRS 332.015 can purchase directly and be billed by vendor.
3. **REPORTING:** Vendors are required to submit quarterly reporting for the State of Nevada only to participating entity contact below. The reporting to include the following:



