The Parties acknowledge that the mutual promises and covenants contained herein and other good and valuable consideration are sufficient and adequate to support this Amendment.

### 5. LIMITS OF EFFECT

This Amendment is incorporated by reference into the Master Agreement, and all prior Amendments thereto, if any, shall remain in full force and effect except as specifically modified herein.

## 6. MODIFICATIONS

The Master Agreement and all prior amendments thereto, if any, shall be modified to reflect the legal name of the Contractor as **GH Armor Systems Inc**.

## 7. ORDER OF PRECEDENCE

In the event of any conflict, inconsistency, variance, or contradiction between the provisions of this Amendment and any of the provisions of the Master Agreement, the provisions of this Amendment shall in all respects supersede, govern, and control.
