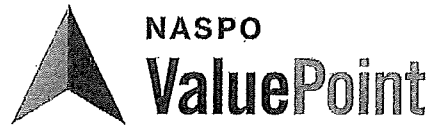
The following changes are modifying or supplementing the Master Agreement terms and conditions.

This fee may be assessed over the term of the contract period. Contractor will be provided 30 days written notice before fee'. Fee's shall be paid quarterly, 45 days after the close of the quarter, on all purchases under the Price Agreement.

5. 

