Dear Mr. Laserna,

This letter shall serve as formal notice that the above referenced contract between Renegade Armor, LLC ("Contractor") and the State of Colorado, acting by and through the Department of Personnel & Administration, State Purchasing & Contracts Office ("Lead State"), has been suspended effective immediately, due to Renegade Armor, LLC no longer being in business, as stated in a letter from Marcus Treiber, dated January 24, 2017, and attached herein.

Mr. Treiber also stated that Propper purchased all of Renegade Armor LLC's assets and has requested that the Master Agreement be transferred to Propper.

Per Section VI.E(1) General Provisions, Assignment/Subcontracts, "Contractor shall not assign, sell, transfer, subcontract or sublet rights, or delegate responsibilities under this Master Agreement, in whole or in part, without the prior written approval of the Lead State."

In order to facilitate an Assignment, acquisition paperwork which supports Mr. Treiber's statement, must be provided to the Lead State no later than February 10, 2017. Upon receipt and review of this paperwork, the Lead State will make a determination regarding the transfer request.

Please note that any Participating Addenda that Renegade Armor, LLC executed under this Master Agreement will also be suspended, and that sales are not permissible until further notice.
