Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

3. Participating State Modifications or Additions to Master Agreement:

The Commonwealth hereby designates All State Agencies and political subdivisions and authorized non-profits located in the Participating States as authorized Participating Entities under this Participating Addendum.

Governing Law – This PA shall be governed and construed in accordance with the laws of the Commonwealth of Kentucky.

The Participating State is agreeing to the terms of the NASPO Master Agreement only to the extent the terms are not in conflict with applicable law.
