- VII. <u>TERMINATION FOR CONVENIENCE</u>: The State may terminate this contract at any time by providing ninety (90) days' notice in writing from the State to the Vendor and to the Lead State. In that event, all finished or unfinished deliverable items prepared by the Vendor under this contract shall, at the option of the State, become its property. If the contract is terminated by the State as provided in this section, the State shall pay for goods services satisfactorily completed and delivered by the Vendor, less any payment or compensation previously made.
- VIII. COMPLIANCE WITH LAWS: Vendor shall comply with all laws, ordinances, codes, rules, regulations, and licensing requirements that are applicable to the conduct of its business and its performance in accordance with this contract, including those of federal, state, and local agencies having jurisdiction and/or authority.
- IX. REPORTING: The Contractor shall furnish a quarterly usage report electronically in EXCEL format to the NC Division of Purchase & Contract detailing all items purchased under this contract, by individual agency. The reports must be emailed to pcreports@doa.nc.gov. The report is to be submitted by the 15th (or next business day) of the month following each quarterly period. For consistency, quarters shall be considered to end on the last day of March, June, September and December of each calendar year. In addition, an annual report must be furnished with the fourth quarter report noting the total spend for the year. Quarterly reports are required even if no activity has occurred.
