- 1. <u>Scope</u>: This addendum covers Cloud Solutions led by the State of Utah for use by state agencies and other entities located in the State of South Dakota authorized by that State's statutes to utilize State contracts with the prior approval of the State's Chief Procurement Official.
- Participation: This NASPO ValuePoint Master Agreement and this Addendum may be used by all state agencies, institutions of higher institution, political subdivisions and other entities authorized to use statewide contracts in the State of South Dakota (the "Purchasing Entities"). Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

Purchasing Entities under this Addendum include all agencies, institutions, officers, boards, commissions and public universities of the State of South Dakota, and all political subdivisions of the State, including counties, municipalities and public school corporations within the State of South Dakota.

Institutions under the control of the Board of Regents may make direct purchases from this agreement using their own procurement guidelines.

Political subdivisions of the State of South Dakota may purchase directly from the Contractor according to their own procurement procedures.

The Contractor may, at the Contractor's discretion, extend pricing from this Addendum to non-profit organizations in South Dakota. Any sales made to non-profit organizations from this Addendum shall be included in any required reports and shall be subject to the NASPO ValuePoint administrative fee set forth in the Master Agreement section 27 (Administrative Fees).

3. All state agency purchases from this Addendum must be processed through the Bureau of Administration, Office of Procurement Management (OPM). Moratorium exemption approval from the Bureau of Information and Telecommunications (BIT) is required. A purchase order issued by OPM will authorize state agency purchases from this Addendum. (This is for internal State of South Dakota use only. Supplier is not mandated to enforce this requirement.).

It is expressly agreed that the terms of this Addendum and any Oracle order shall supersede the terms in any purchase order, procurement internet portal or any other similar non-Oracle document and no terms included in any such purchase order, portal or other non-Oracle document shall apply to the Services ordered.
