NINTH AMENDMENT
TO
CONTRACT NO. 01611
POLICE RADAR, LIDAR PARTS AND EQUIPMENT

This Ninth Amendment ("Amendment") to Contract No. 01611 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency ("State") and Kustom Signals, Inc., a Kansas corporation ("Contractor") and is dated as of August 24, 2018.

RECITALS

- A. State and Contractor (collectively the "Parties") entered into that certain Contract No. 01611 for Police Radar, Lidar, Parts and Equipment dated effective as of October 31, 2011 ("Contract").
- B. The parties previously amended the Contract six (8) times.
 - 1. Amendment 1 issued February 14, 2012 (Expand product availability).
 - 2. Amendment 2 issued July 1, 2013 (Management Fee).
 - 3. Amendment 3 issued October 31, 2013 (Contract Extension).
 - 4. Amendment 4 issued May 8, 2014 (Expand product availability).
 - 5. Amendment 5 issued April 24, 2015 (Management Fee).
 - 6. Amendment 6 issued July 22, 2015 (Contract Extension).
 - 7. Amendment 6 issued July 22, 2015 (Contract Extension).
 - 8. Amendment 7 issued April 22, 2016 (Expand product availability).
 - 9. Amendment 8 issued October 1, 2017 (Expansion product availability).
- C. The amendment set forth herein is within the scope of the Contract.
- D. The Parties now desire to amend the Contract as set forth herein.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

1. Covered Products. The Content is amended to expand the products included in the Contract to include the products listed below.

2. NO CHANGE OTHER THAN AMENDMENT. Except as amended herein, the Contract is unaffected and remains in full force and effect.
3. INTEGRATED AGREEMENT; MODIFICATION. This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
4. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
5. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this

Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.
