a) Shipping and Delivery:

All deliveries shall be F.O.B. destination anywhere within the boundaries of the State of Alaska via standard shipping i.e. USPS or FedEx or UPS ground service. No freight or handling charges will apply unless the ordering agency requests expedited or special handling requirements. Special handling may include items that exceed standard ground delivery weights or size limits.

b) Administrative Fee

The contractor shall provide a quarterly administrative fee of 1.5% to the State of Alaska. The contractor shall submit a check, payable to the State of Alaska, Department of Administration.
