On December 21, 2018, State of Oregon, Department of Administrative Services (DAS), Procurement Services (PS) received a letter from MyOfficeProducts and SheppardMullin, counsel for Staples. Both letters were dated December 20, 2018. These afore mentioned letters informed DAS PS that MyOfficeProducts had terminated its relationship with Metro Office Solutions, Inc. and MyOfficeProducts would not be serving as the wholesaler for Metro Office Solutions.

The MyOfficeProducts letter stated that all orders received prior to January 4, 2019, would be fulfilled and any order after that date would not be processed.

On February 20, 2019 DAS PS received a termination letter dated February 20, 2019 which stated that My Office Solutions could not fulfill its obligation for the NASPO ValuePoint, Master Agreement PA5738 and requested an immediate termination of the Master Agreement.

This letter is being sent to your firm to provide confirmation that your Master Agreement is terminated.

The Department of Administrative Services (DAS), Procurement Services (PS) on behalf of the NASPO ValuePoint, shall terminate this Master Agreement, per Section 2.20.1 of said agreement. Also, Per Section 2.21, Access to Records which states: "Contractor shall retain, maintain, and keep accessible all records relevant to the this Contract (the "Records") for a minimum of six (6) years, or such longer period as may be required by applicable law following expiration or termination of the Contract."
