Scope: This addendum covers the Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories led by the State of Washington for use by state agencies and other entities located in the Participating State *[or State Entity]* authorized by that State's statutes to utilize State contracts with the prior approval of the State's Chief Procurement Official.
2. Participation: This NASPO ValuePoint Master Agreement may be used by all state agencies, institutions of higher institution, political subdivisions and other entities authorized to use statewide contracts in the State of Wisconsin. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

No changes to the terms and conditions of the Master Agreement are required.

The following changes are modifying or supplementing the Master Agreement terms and conditions.

- A. State of Wisconsin Contract Number is 505ENT-O19-POLICERADAR-03.
- B. The State of Wisconsin Standard Terms and Conditions (DOA-3054, revised R1/2018) as attached become part of this Participating Addendum. (Attachment 1)
- C. The State of Wisconsin's Participating Addendum will be governed by the Master Agreement and the State of Wisconsin's additional terms and conditions.
- D. The State of Wisconsin Standard Terms and Conditions shall prevail if there is a conflict between Wisconsin's and NASPO ValuePoint's Terms and Conditions.
- E. The Contractor must sign and include the Cooperative Purchasing Agreement to allow municipalities, as defined on the Agreement, to purchase through this addendum. (Attachment 2)
- F. This Participating Addendum shall be effective upon approval by Wisconsin's Department of Administration and shall continue until the end date of the NASPO ValuePoint contract. NASPO ValuePoint amendments to renew the term date are automatically incorporated into this Participating Addendum unless terminated early in accordance with the terms and conditions of the NASPO ValuePoint contract or this Participating Addendum.
- G. The State of Wisconsin, Department of Administration may terminate this contract at any time upon 60-day prior written notice. Upon termination or other expiration of this contract, each party shall assist the other party in orderly termination of the contract and the transfer of all assets, tangible and intangible, as may facilitate the orderly, non-

disrupted business continuation of each party. This provision shall not relieve the contractor of the obligation to perform under any purchase order or other similar ordering document executed prior to termination becoming effective.

H. Semi-annual sales reports shall be submitted electronically, by Contractor, to the Participating Entity. These reports shall be in excel format and shall at a minimum include the following identifying fields; Reporting Period, Agency Name, Order Date, Product Description, Quantity Purchased, Unit Price and Extended Price. The Contractor agrees to provide additional reports, if requested, to the State in a format and frequency as mutually agreed by both parties.



5. Lease Agreements: **Lease Agreements Are NOT Authorized by this Contract.**
6. Subcontractors: All contactors, dealers, and resellers authorized in the State of *Wisconsin*, as shown on the dedicated Contractor (cooperative contract) website, are approved to provide sales and service support to participants in the NASPO ValuePoint Master Agreement. The contractor's dealer participation will be in accordance with the terms and conditions set forth in the aforementioned Master Agreement.
7. Orders: Any order placed by a Participating Entity or Purchasing Entity for a product and/or service available from this Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions) of the Master Agreement unless the parties to the order agree in writing that another contract or agreement applies to such order. All orders issued by purchasing entities within the State of Wisconsin must include the Participating State contract number: 505ENT-O19-POLICERADAR-03 as well as the Lead State Master Agreement number 00218.
