Master Agreement Terms and Conditions:

1. **Scope:** This addendum covers the **Truck Rental Services** led by the State of Connecticut for use by state agencies and other entities located in the Participating **State of South Dakota** authorized by that State's statutes to utilize State contracts with the prior approval of the State's Chief Procurement Official.
2. **Participation:** The NASPO ValuePoint Master Agreement (the "Master Agreement") may be used by all state agencies, institutions of higher institution, political subdivisions and other entities authorized to use statewide contracts in the **State of South Dakota**. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

Eligible participants in this Participating Addendum include all agencies, institutions, officers, boards, commissions and public universities of the State of South Dakota, and all political subdivisions of the State, including counties, municipalities and public school corporations within the State of South Dakota.

Institutions under the control of the Board of Regents may make direct purchases from this Participating Addendum and the Master Agreement using their own procurement guidelines.

Political subdivisions of the State of South Dakota may purchase directly from the Contractor hereunder according to their own procurement procedures.

The Contractor may, at the Contractor's discretion, extend pricing from the Master Agreement to Indian tribal governments and non-profit organizations in South Dakota. Any sales made to Indian tribes and non-profit organizations under this Participating Addendum shall be included in any required reports and shall be subject to the NASPO Valuepoint administrative fee.

The contractor's dealer participation will be in accordance with the terms and conditions set forth in the aforementioned Master Agreement.
7. Orders: Any order placed by a Participating Entity or Purchasing Entity for a product and/or service available from this Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions of) the Master Agreement unless the
