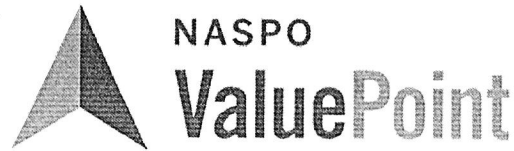
Political subdivisions of the State of South Dakota may purchase directly from the Contractor according to their own procurement procedures.


