

**PARTICIPATING ADDENDUM

**State of Alaska**  
(hereinafter "Participating State")

This Participating Addendum for the above referenced Master Agreement ("Participating Addendum") is made and entered into by and between the State of Alaska, acting by and through the Department of Administration, Division of Shared Services, an Alaska State governmental agency ("PARTICIPATING STATE") and Decatur Electronics ("Contractor") and is effective as of the final date provided on the signature page (page 4) of this document.

1. **SCOPE:** This Participating Addendum covers NASPO Police Radar, Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories led by the State of Washington for use by state agencies and other entities located in the Participating State authorized by that state's statutes to utilize state contracts with the prior approval of the State's chief procurement official.
2. **PARTICIPATION:** Use of specific NASPO ValuePoint cooperative contracts by agencies, political subdivisions and other entities (including cooperatives) authorized by an individual state's statutes to use state contracts are subject to the prior approval of the respective State chief procurement official. Issues of interpretation and eligibility for participation are solely within the authority of the State chief procurement official.
3. **ORDERS:** Unless the parties to the Order agree in writing that another contract or agreement applies to such order, any Order placed by a Participating Entity or Purchasing Entity for a Product and/or Service available from this Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions of) the Master Agreement as conditioned by this Participating Addendum and the pricing provided for this Master Agreement by Decatur Electronics.
4. **SUBCONTRACTORS:** All Contractor's Distributors authorized in the State of Alaska, as shown on the dedicated Contractor NASPO ValuePoint website, are approved to provide sales and service support to participants in the NASPO ValuePoint Master Agreement. The Contractor's Distributor's participation will be in accordance with the terms and conditions set forth in the aforementioned Master Agreement.

5. PARTICIPATING STATE MODIFICATIONS OR ADDITIONS TO MASTER AGREEMENT:

5.1 Purchase Orders Numbers: All Purchase Orders issued by the purchasing entities within the jurisdiction of this Participating Addendum shall include the NASPO Master Agreement number: **00218**, and the assigned Alaska PA number: **PRL-004AK**.

5.2 Reporting: Contractor must submit quarterly reports to the State of Alaska with an electronic usage report, which must list the purchasing entity, description of item(s) purchased, date, retail price, extended price and total quarterly state spend. These reports are due within thirty (30) days of the end of the quarter in accordance with the Master Agreement and State of Alaska Fiscal Quarters.

5.3 Administrative Fee: Contractor agrees to provide an administrative fee to the State of Alaska.

(a) Contractor shall submit a check, payable to the State of Alaska, remitted to the Department of Administration, Division of Shared Services for the calculated amount equal to 1.5% of the net sales for the quarterly period.

(b) Administrative fees are due within thirty (30) days of the end of the quarter.

(c) Contractor must include the PA Number **PRL-004AK** on the check. Those checks submitted to the State without the PA Number will be returned to Contractor for additional identifying information.

(d) The Administrative fee shall not be included as an adjustment to the Contractor's Master Agreement pricing and shall not be invoiced or charged to the ordering agency.

(f) Payment of the administrative fee is due irrespective of payment status on any orders from a Purchasing Entity.

(g) Any quarter with zero sales must be reported as zero sales. This may be done electronically via email to the State of Alaska contact person listed on this PA.

5.4 Order of Precedence: The parties acknowledge and agree that in the event of a conflict

between the terms contained in the various documents comprising this Agreement, the following order of precedence will control: (a) this PA; (b) the Master Agreement, (c) any Purchase Order issued in connection therewith. This section specifically supersedes, and order of precedence provision set forth elsewhere in the Agreement.

6. **LEASE AGREEMENTS:** Leasing, renting, or purchasing equipment is not allowed throughout the term of the Master Agreement.

This Participating Addendum may not be modified except in writing signed by the Parties.
- (b) **AUTHORITY:** Each party to this Participating Addendum, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Participating Addendum and that its execution, delivery, and performance of this Participating Addendum has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
- (c) **ELECTRONIC SIGNATURES:** A signed copy of this Participating Addendum or any other ancillary agreement transmitted by facsimile, email, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original executed copy of this Participating Addendum or such other ancillary agreement for all purposes.




