1. Scope

This Participating Addendum covers the NASPO ValuePoint Wireless Voice, Data, and Accessories Master Agreement led by the State of Utah, as amended as of the Participating Addendum Effective Date (Master Agreement No. MA176) for use by all state agencies and local government entities, institutions of higher education, and school districts located in the State of Louisiana who are authorized by the State of Louisiana statutes to utilize state contracts.

2. Participation

Use of specific NASPO ValuePoint cooperative contracts by State agencies, political subdivisions and other entities (including cooperatives) authorized by the State of Louisiana's statutes to use state contracts are subject to the prior approval of the State of Louisiana's Chief Procurement Officer. Issues of interpretation and eligibility for participation in the State's program are solely within the authority of the State Chief Procurement Officer.

3. Term

The term of this Participating Addendum and State Contract Number 4400020636 shall be effective

upon the date of final execution below (the "Effective Date") by the State of Louisiana through August 11, 2024, unless otherwise terminated in accordance with the termination provisions of this Participating Addendum or the Master Agreement. This Participating Addendum and State Contract Number 4400020636 may be extended in accordance with the terms and conditions of the Master Agreement.

4. Non-Exclusive Contract

This Participating Addendum and State Contract Number 4400020636 are non-exclusive and shall not in any way preclude State Agencies or Political Subdivisions of the State of Louisiana from entering into similar agreements, contracts and/or arrangements with other vendors or from acquiring similar, equal or like goods and/or services from other entities or sources.

5. Order of Precedence.

Except as specifically provided otherwise herein, this Participating Addendum and State Contract Number 4400020636 consists of and precedence is established by the order of the following documents:

- This Participating Addendum; and
- The Master Agreement (including the Master Agreement Order of Precedence established in the NASPO ValuePoint Master Terms and Conditions).

6. Modifications and/or Additions to the Master Agreement

A. Administrative Fee or Rebate:

The Contractor shall pay a 1% administrative fee or rebate to the State of Louisiana, Office of State Procurement (OSP). The administrative fee or rebate shall be submitted quarterly and shall be based on the total net (gross sales minus any charges for taxes or shipping, returns, credits and deductions) sales to entities located in the State of Louisiana through State Contract Number 4400020636. Initiation and submission of the administrative fee or rebate to OSP is the responsibility of the Contractor without prompting or notification by the State Procurement Analyst (SPA). If these administrative fees or rebates are not submitted in a timely manner, OSP shall have the right to terminate this Participating Addendum and State Contract Number 4400020636.

The check is to be made payable to: Louisiana DOA-Office of State Procurement. The check is to be mailed to the Office of State Procurement, Attn: OSP Receivables Specialist, either through the U.S. Postal Service to OSP's box at: P. O. Box 94095, Baton Rouge, LA 70804-9095 or through a courier service to OSP's physical location at: 1201 North 3rd Street, Suite 2-160, Baton Rouge, LA 70802. Payment shall be made in accordance with the following schedule:

THAN ONE (1) CONTRACT, CONTRACTOR SHALL INDICATE ALL STATE CONTRACT NUMBERS AND THE AMOUNT FOR EACH.

B. Usage Reports:

The Contractor shall submit detailed contract usage reports quarterly to the State Procurement Analyst (SPA) for State Contract Number 4400020636 in accordance with the below schedule. Initiation and submission of the quarterly reports to the SPA is the responsibility of the Contractor without prompting or notification by the SPA. If these reports are not submitted in a timely manner, the Office of State Procurement (OSP) shall have the right to terminate State Contract Number 4400020636.

The specific usage report content, scope, and format requirements are available on the OSP website under Purchasing/Vendor Center/Vendor Forms:

In addition, the person's name who compiled the report and their contact information shall be provided.

The usage reports shall be submitted utilizing this format or an equivalent format that has been pre-approved by OSP. Schedule for submittal of usage reports:

C. Modifications:

No amendment or modification of the terms of this Participating Addendum shall be valid unless made in writing, signed by the parties and approved as required by law. No oral understanding or agreement not incorporated in this Participating Addendum is binding on any of the parties.

D. Amendments:

Any further Amendments to the Master Agreement after the Effective Date of this Participating Addendum, that (a) have been approved by the Lead State and (b) reasonably should be considered to have a material adverse effect on the Participating Entity's rights and/or obligations under the NASPO Master Agreement No. MA176, will not be applicable to this Participating Addendum and will not be valid unless made in writing as an amendment to this Participating Addendum, signed by the parties and approved as required by the laws of the State of Louisiana. Furthermore, it is agreed and acknowledged by the parties that, notwithstanding the foregoing, any amendments made by the Lead State pursuant to Attachment B, Section 7 of the Master Agreement, will apply to this Participating Addendum without the need for further written consent by the Participating State. No oral understanding or agreement not incorporated in this Participating Addendum is binding on any of the parties.

E. Assignment:

The Contractor shall not assign any interest in this Participating Addendum or State Contract Number 4400020636 by assignment, transfer or novation without prior written consent of the State, which consent shall not be unreasonably withheld, conditioned or

delayed. This provision shall not be construed to prohibit the Contractor from assigning his bank, trust company, or other financial institution any money due or to become due from approved contracts without such prior written consent. Notice of any such assignment or transfer shall be furnished promptly to the State.

F. Termination:

The State of Louisiana has the right to terminate this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 immediately upon written notice to Contractor for any of the following reasons: (a) Contractor's fraud, collusion, conspiracy or other unlawful means of obtaining any contract with the State of Louisiana; (b) conflict of contract provisions with constitutional or statutory provisions of State or Federal Law; (c) abusive or belligerent conduct by the Contractor towards an employee or agent of the State of Louisiana; (d) Contractor's intentional violation of the Louisiana Procurement Code (La. R.S. 39:1551 et seq.) and its corresponding regulations; or, (e) any listed reason for debarment under La. R.S. 39:1672.

Termination for Cause:

The State of Louisiana may terminate this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 for cause based upon the failure of Contractor to comply with the terms and/or conditions of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 provided that the State shall give the Contractor written notice specifying the Contractor's failure. If within thirty (30) days after receipt of such notice, the Contractor shall not have corrected such failure or, in the case of failure which cannot be corrected in thirty (30) days, begun in good faith to correct such failure and thereafter proceeded diligently to complete such correction, then the State may, at its option, place the Contractor in default and this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 shall terminate on the date specified in such notice.

The Contractor may exercise any rights available to it under Louisiana law to terminate for cause upon the failure of the State to comply with the terms and conditions of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636, provided that the Contractor shall give the State written notice specifying the State's failure and a reasonable opportunity for the State to cure the defect.

Termination for Convenience:

The State of Louisiana may terminate this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 for convenience at any time (1) by giving thirty (30) days written notice to the Contractor of such termination; or (2) by negotiating with the Contractor an effective date. The State shall pay the Contractor for, if applicable: (a) deliverables in progress; (b) the percentage that has been completed satisfactorily; and, (c) for transaction-based services up to the date of termination, to the extent work has been performed satisfactorily.

Termination for Non-Appropriation of Funds:

The continuation of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 is contingent upon the continuation of an appropriation of funds by the legislature to fulfill the requirements of this

Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636. If the legislature fails to appropriate sufficient monies to provide for the continuation of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636, or if such appropriation is reduced by the veto of the Governor or by any means provided in the appropriations act or Title 39 of the Louisiana Revised Statutes of 1950 to prevent the total appropriations for the year from exceeding revenues for that year, or for any other lawful purpose, and the effect of such reduction is to provide insufficient monies for the continuation of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636; this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 shall terminate on the date of the beginning of the first fiscal year for which funds are not appropriated. The Participating Entity will be responsible for payment of all charges and fees incurred for Products and Services ordered by and provided to the Participating Entity prior to such termination date, notwithstanding any lack of allocable or appropriation of funds). At Contractor's request, Participating Entity will provide supplemental documentation regarding the non-appropriation of funds. Participating Entity must take all necessary action to budget and secure any funds required to fulfill its contractual obligations for each fiscal year.

The Participating Entity shall make a commercially reasonable effort to provide Contractor with written notice of any termination for non-appropriation at least thirty (30) days before the effective date of the termination. The Contractor should be aware that our legislative process is such that it is often impossible to give prior notice of the non-appropriation of funds.

G. Default of Contractor:

Failure to provide goods and/or services within the time frame(s) specified and according to the other terms and conditions specified in this Participating Addendum and State Contract Number 4400020636 constitutes a default by the Contractor and may cause cancellation of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636. Subject to the dispute resolution provision in the Master Agreement or any dispute resolution process available under applicable law, in the event Contractor fails to fulfill or comply with this Participating Addendum, the State reserves the right to purchase any or all products or services covered by this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 on the open market and to charge the Contractor with cost in excess of the contract price, all in accordance with Louisiana Revised Statutes 39:1661.C. Until such assessed charges have been paid, no subsequent bid from the defaulting Contractor will be considered.

H. Governing Law:

This Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 shall be governed by and interpreted in accordance with the laws of the State of Louisiana. Venue of any action brought with regard to this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 shall be in the Nineteenth Judicial District Court, parish of East Baton Rouge, State of Louisiana.

- I. Taxes:**
Any taxes, other than State and local sales and use taxes from which the State of Louisiana is exempt, shall be assumed to be included within the total cost.
- J. Electronic Vendor Payment Solutions:**
The State desires to make payments electronically. The methods of payment may be via the State's LaCarte card (procurement card) or EFT payments sent directly from the State's bank directly to the payee's bank. See **Attachment A-Electronic Vendor Payment Solutions** of this Participating Addendum for additional information regarding electronic payment methods.
- K. Late Payments:**
Interest due by a State agency for late payments shall be in accordance with La. R.S. 39:1695 at the rates established in La. R.S. 13:4202.
- L. Public Information:**
For the purposes of this Participating Addendum, the provisions of the Louisiana Public Records Act (La. R.S. 44.1 et. seq.) will be in effect.
- M. Contract Controversies:**
Any claim or controversy arising out of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636, shall be resolved by the provisions of Louisiana Revised Statute 39:1673.
- N. Code of Ethics:**
The Contractor acknowledges that Chapter 15 of Title 42 of the Louisiana Revised Statutes (La. R.S. 42:1101 et. seq., Code of Governmental Ethics) applies to the Contracting Party in the performance of services called for in this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636. The Contractor agrees to notify the State of Louisiana in a commercially reasonable timeframe if potential violations of the Code of Governmental Ethics arise at any time during the term of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636.
- O. Right to Audit:**
The State of Louisiana Legislative Auditor, Federal Auditors and Internal Auditors of the Louisiana Division of Administration (DOA), or others so designated by the DOA, shall have the option to audit all Contractor accounts directly pertaining to this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 for a period of five (5) years from the date of final payment made under this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 or as required by applicable State and Federal Law. Records shall be made available upon prior written notice at Contractor's business offices by the Contractor during normal working hours for this purpose.
- P. Record Retention:**
The Contractor shall maintain all records in relation to this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 for a period of at least five (5) years after final payment.

Q. Contractors Cooperation/Close-Out:

The Contractor has the duty to fully cooperate with the State and make a commercially reasonable effort to provide any and all requested information, documentation, etc. to the State when requested. Notwithstanding the foregoing, Contractor's failure to provide such information will not be deemed a material breach of this Participating Addendum so long as Contractor is using reasonable good faith efforts to provide such information to the State. This applies even if this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636 is terminated and/or a lawsuit is filed. Specifically, the Contractor shall not limit or impede the State's right to audit or to withhold State owned documents.

R. Contractor's Certification of No Federal Suspension or Debarment:

By signing this Participating Addendum, the Contractor certifies that their company, any subcontractors, or principals are not suspended or debarred by the General Services Administration (GSA) in accordance with the requirements in "Audit Requirements in Subpart F of the Office of Management and Budget's Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards" (formerly OMB Circular A-133).

A list of parties who have been suspended or debarred can be viewed via the internet at <https://www.sam.gov>.

Contractor has a continuing obligation to disclose any suspensions or debarment by any government entity, including but not limited to General Services Administration (GSA). Failure to disclose may constitute grounds for suspension and/or termination of the Contract and debarment from future contracts.

S. Secretary of State Registration Requirement:

In accordance with Louisiana law, all corporations (see La. R.S. 12:262.1) and limited liability companies (see La. R.S. 12:1308.2) must be registered and in good standing with the Louisiana Secretary of State in order to hold a purchase order and/or a contract with the State.

T. Prohibition of Discriminatory Boycotts of Israel:

In accordance with La. R.S. 39:1602.1, for any contract with a value of \$100,000 or more and for any Contractor with five (5) or more employees, the Contractor, or Subcontractor, shall certify that it is not engaging in a boycott of Israel and shall, for the duration of its contractual obligations, refrain from a boycott of Israel.

The State of Louisiana reserves the right to terminate this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636, if the Contractor, or any Subcontractor, engages in a boycott of Israel during the term of this Participating Addendum, State Contract Number 4400020636, or any order issued pursuant to State Contract Number 4400020636.

7. Louisiana Pricing Schedule ("LAPS") Contract

State Contract Number 4400020636 has been designated as a Louisiana Pricing Schedule ("LAPS") contract and LAC 34.V.1709 must be followed by Louisiana purchasing entities utilizing State Contract Number 4400020636.

The Parties will keep and maintain current at all times a primary point of contact for administration of this Participating Addendum.

9. Employee Benefit Program

The State of Louisiana will participate with the Contractor in efforts to obtain eligible Employees' participating in the Employee Advantage Program pursuant to Attachment AA, Section 2 of the Master Agreement.

10. Signature Authority

Evidence of signature authority to contract with the state of Louisiana must be provided. One of the following must apply to the Contractor:

- a) The signer of this Participating Addendum is either a corporate officer who is listed on the most current annual report on file with the Secretary of State or a member of a partnership or partnership in commendam as reflected in the most current partnership records on file with the Secretary of State. **A copy of the annual report or partnership record must be submitted to the Louisiana Office of State Procurement before finalization of this Participating Addendum.**
- b) The signer of this Participating Addendum is a representative of the Contractor authorized to sign this Participating Addendum as evidenced by documents such as, corporate resolution, certification as to corporate principal, etc. **If this applies a copy of the resolution, certification or other supportive documents must be submitted to the Louisiana Office of State Procurement before finalization of this Participating Addendum.**

- c) The Contractor has filed with the Secretary of State an affidavit or resolution or other acknowledged/authentic document indicating that the signer is authorized to sign this Participating Addendum. **A copy of the applicable document must be submitted to the Office of State Procurement before finalization of this Participating Addendum.**
- d) The signer of this Participating Addendum has been designated by the Contractor as authorized to sign this Participating Addendum on the Contractor's vendor registration on file with the Louisiana Office of State Procurement.

11. Orders

Any Order placed by a Participating Entity or Purchasing Entity for a Product and/or Service available from this Participating Addendum and/or State Contract Number 4400020636 shall be deemed to be a sale under (and governed by the prices and other terms and conditions) of the Master Agreement. As a pre-condition to ordering Services and/or Products under this Participating Addendum, Contractor will require Participating Entity or Purchasing Entity to provide a Purchase Order.

12. Technology Evolution.

- a) In the normal course of technology evolution and enhancement, Contractor continually updates and upgrades its Services, Products and networks. In some instances, these efforts will result in the need to ultimately replace or discontinue certain offerings or technologies. In such event, Contractor will undertake such efforts in a customer-focused and commercially reasonable manner. Accordingly and notwithstanding anything in the Participating Addendum, State Contract Number 4400020636 to the contrary, Contractor reserves the right, in its sole discretion, after providing the notice set forth in subsection b) below, to: (a) migrate Purchasing Entities to a replacement technology; or (b) discontinue any Service, Product, network standard, or technology without either party being in breach of the Participating Addendum, State Contract Number 4400020636 or incurring early termination liability relating to the discontinuance of the affected Service, Product, network standard, or technology.
- b) If Contractor takes any action set forth in subsection a) above, Contractor will provide advance notice reasonably designed to inform Purchasing Entities (if affected) of such pending action. The form of Contractor's notice may include providing written notice to any address (a) listed in the Participating Addendum, State Contract Number 4400020636 for Participating State, (b) T-Mobile uses for billing, or (c) set forth in an Order. Customer agrees that such notice is reasonable and sufficient notice of Contractor's pending action.

13. Software Terms and Conditions.

Purchasing Entities that acquire software shall be subject to the license agreements distributed with such software; however, in the event of a conflict in language between an end user license agreement (EULA) and the Master Agreement, the language in the Master Agreement will supersede and control. In addition, any language in a EULA which violates a Purchasing Entity's constitution, statute or other applicable law will be deemed void, and of no force or effect, as applied to the Purchasing Entity.

14. Existing 1907 Participating Addendums.



Pursuant to Amendment No. 2 of Master Agreement No. MA176, upon execution of this Participating Addendum, the parties agree that the terms of any existing Participating Addendum(s) under either: 1)

the NASPO ValuePoint Master Agreement #1907 between the State of Nevada and Contractor ("T-Mobile NASPO 1907 Agreement"); or 2) the NASPO ValuePoint Master Agreement #1907 between the State of Nevada and Sprint Solutions, Inc., ("Sprint NASPO 1907 Agreement") will be governed under the terms of this Participating Addendum and Master Agreement No. MA176. Contractor and the Participating State agree that this Participating Addendum will supersede and replace any existing Participating Addendum(s) under either T-Mobile NASPO 1907 Agreement or Sprint NASPO 1907 Agreement ("Existing 1907 Participating Addendums") as of the Participating Addendum Effective Date, subject to the terms herein. The Existing 1907 Participating Addendums will be terminated in their entirety as of the Participating Addendum Effective Date.

15. Entire Agreement

This Participating Addendum and the NASPO ValuePoint Master Agreement together with its exhibits, set forth the entire agreement between the parties with respect to the subject matter and supersedes all previous communications, representations or agreements, whether oral or written. Terms and conditions inconsistent with, contrary or in addition to the terms and conditions of this Participating Addendum and the NASPO ValuePoint Master Agreement, together with its exhibits, shall not be added to or incorporated into this Participating Addendum or the NASPO ValuePoint Master Agreement and its exhibits, by any subsequent Purchase Order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of this Participating Addendum and the NASPO ValuePoint Master Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.

ATTACHMENT A – Electronic Vendor Payment Solutions

In an effort to increase efficiencies and effectiveness as well as be strategic in utilizing technology and resources for the State and Contractor, the State intends to make all payments to Contractors electronically. The LaCarte Procurement Card will be used for purchases of \$5,000 and under, and where feasible, over \$5,000. Contractors will have a choice of receiving electronic payment for all other payments by selecting the Electronic Funds Transfer (EFT). If you receive an award and do not currently accept the LaCarte card or have not already enrolled in EFT, you will be asked to comply with this request by choosing either the LaCarte Procurement Card and/or EFT. You may indicate your acceptance below.

The LaCarte Procurement Card uses a Visa card platform. Contractors receive payment from state agencies using the card in the same manner as other Visa card purchases. Contractors cannot process payment transactions through the credit card clearinghouse until the purchased products have been shipped or received or the services performed.

For all statewide and agency term contracts:

- Under the LaCarte program, purchase orders are not necessary. Orders must be placed against the net discounted products of the contract. All contract terms and conditions apply to purchases made with LaCarte.
- If a purchase order is not used, the Contractor must keep on file a record of all LaCarte purchases issued against this contract during the contract period. The file must contain the particular item number, quantity, line total and order total. Records of these purchases must be provided to the Office of State Procurement on request.

EFT payments are sent from the State's bank directly to the payee's bank each weekday. The only requirement is that you have an active checking or savings account at a financial institution that can accept Automated Clearing House (ACH) credit files and remittance information electronically.
