1. Scope: This addendum covers the Body Armor and Ballistic Resistant Products led by the State of Colorado for use by state agencies and other entities located in the Participating State/Entity authorized by that state's statutes to utilize state/entity contracts with the prior approval of the State's Chief Procurement Official.
2. Participation: Use of specific NASPO ValuePoint cooperative contracts by agencies, political subdivisions and other entities (including cooperatives) authorized by an individual state's statutes to use state/entity contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.
3. Participating State/Entity Modifications or Additions to Master Agreement: (These modifications or additions apply only to actions and relationships within the Participating Entity.)

4. Shipping - Free on Board

Contractor is responsible for transportation and handling charges, and the sale does not occur until the products arrive at the Purchasing Entity's specified location.

## 5. Required Reports

Contractor must submit quarterly reports to the Contracting Officer assigned by the State of to manage this contract. The contractor shall provide the State of Alaska with an electronic usage report (excel) which will list the following information at the minimum: Purchasing entity, description of items purchased, date of purchase, contract price, retail price, and extended price for each transaction. These reports are due 30 days after the end of the quarter.

## 6. Administrative Fee:

Contractor agrees to provide an Administrative Fee to the State of Alaska.
a. Contractor shall submit a check, payable to the State of Alaska, remitted to the Department of Administration, Division of General Services for the calculated amount equal to $1.5 \%$ of the net sales for the quarterly period.
b. Contractor must include the Contract Name (Body Armor) and PA Number (2021BA09) on the check. Those checks submitted to the State without these identifiers will be returned to the contractor for additional identifying information.

d. The Administrative fee shall not be included as an adjustment to the contractors Master Agreement pricing and shall not be shown as a sperate line item invoiced or charged to the Purchasing Agency.
e. Payment of the administrative fee is due irrespective of payment status on orders from a Purchasing Agency.
f. Administrative fee checks/payments are due for each quarter as follows:
