**AMENDMENT NO. 4 TO MASTER MNNVP-134, MN CONTRACT NO. 97228, RELEASE NO. C-871(5)**

**THIS AMENDMENT** is by and between the State of Minnesota, acting through its commissioner of Administration (“State”), in cooperation with NASPO ValuePoint and Hewlett Packard Enterprise Company, 3000 Hanover St, Palo Alto, CA 94304 (“Contract Vendor”).

**WHEREAS**, the State has a Contract with the Contract Vendor identified as Contract No. 97228, with a term beginning September 10, 2015 through July 31, 2021, to provide Computer Equipment; and

**WHEREAS**, Minn. Stat. § 16C.03, subd. 5, affords the commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

**WHEREAS**, the terms of the Contract allow the State to amend the Contract as specified herein, upon the mutual agreement of the Office of State Procurement and the Contract Vendor in a fully executed amendment to the Contract.

**NOW, THEREFORE**, it is agreed by the parties to amend the Contract as follows:

- 1. That Contract No. 97228 is extended through July 31, 2022, at the same prices, terms, and conditions.

This Amendment is effective August 1, 2021 or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Contract is canceled, whichever occurs first.

Except as herein amended, the provisions of the Contract between the parties hereto are expressly reaffirmed and remain in full force and effect.
