## AMENDMENT #3 to MASTER AGREEMENT#8327

This is Amendment #3 to Master Agreement #8327, as amended from time to time (the "Master Agreement"), between the State of Oregon, acting by and through its Department of Administrative Services, Enterprise Goods and Services, Procurement Services ("DAS PS") on behalf of the member states of the NASPO ValuePoint Cooperative Purchasing Program, and Abbott Nutrition, Abbott Laboratories, Inc. ("Contractor"). This Amendment is effective on the date signed by all parties.

Contractor certifies that the representations, warranties and certifications contained in the original Master Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.

By signature on this Amendment, the individual signing below on behalf of Contractor certifies under penalty of perjury that: a) the undersigned is authorized to act on behalf of Contractor; and b) the representations, warranties and certifications contained in the original Master Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.; and c) the undersigned is authorized to act on behalf of Contractor and that Contractor is, to the best of the undersigned's knowledge, not in violation of any Oregon Tax Laws. For purposes of this certification, "Oregon Tax Laws" means a state tax imposed by ORS 320.005 to 320.150 and 403.200 to 403.250 and ORS chapters 118, 314, 316, 317, 318, 321 and 323 and the elderly rental assistance program under ORS 310.630 to 310.706 and local taxes administered by the Department of Revenue under ORS 305.620.
