

**AMENDMENT No. 21 to  
MASTER AGREEMENT# 6485**

I. This is Amendment No. 21 to Master Agreement #6485 dated November 30, 2016, as amended from time to time (“Master Agreement”) between the State of Oregon, acting by and through its Department of Administrative Services, Procurement Services office (“DAS PS”) on behalf of the member states of the NASPO ValuePoint Cooperative Purchasing Program and Playpower dba Playworld Systems, Inc. hereafter called "Contractor."
