Contractor reserves the right to terminate a Purchasing Entity's ability to purchase under this PA if at any time it is determined that Purchasing Entity is not eligible to purchase under this PA.

4. Participating Entity Modifications Or Additions To The Master Agreement

☑ THIS PARTICIPATING ADDENDUM INCORPORATES ALL TERMS AND CONDITIONS OF THE MASTER AGREEMENT AS APPLIED TO THE PARTICIPATING ENTITY AND CONTRACTOR, SUBJECT TO THE FOLLOWING LIMITATIONS, MODIFICATIONS, AND ADDITIONS:

1) Required Reports: Contractor must submit quarterly reports to doa.dss.vendorreport@alaska.gov and "Cc" the Contracting Officer assigned by the State to manage this contract. The contractor shall provide the State of Alaska with an electronic usage report (Excel) which will list the following information at the minimum: Purchasing Entity, Purchase made by SOA or other, description of items purchased, date of purchase, contract price, retail price, and the extended price for each transaction. These reports are due 30 days after the end of the quarter.

First Quarter: July 1 through September 30
Second Quarter: October 1 through December 31
Third Quarter: January 1 through March 31
Fourth Quarter: April 1 through June 30

- 2) Administrative Fee: Effective upon final signature, the Contractor shall submit a check, payable to the State of Alaska, remitted to the Department of Administration, Office of Procurement and Property Management, for the calculated amount equal to 1.5% of the net sales for the guarterly period.
 - a) Contractor must include the PA Number on the check. Those checks submitted to the State without the PA Number will be returned to Contractor for additional identifying information.
 - b) Administrative fee checks shall be submitted to:

- c) The administrative fee may be included as an adjustment to Contractor's Master Agreement pricing.
- d) Payment of the administrative fee is due irrespective of payment status on any orders from a Purchasing Entity.
- e) Administrative fee checks are due for each quarter as follows:

- f) Any quarter with zero sales must be reported as zero sales. This may be done electronically via email to the State of Alaska contact listed in this PA.
- 3) Freight Terms: All freight costs for shipments to the closest appropriate coast shipping port for Alaska must be included in the Contract Price offered to the Participating Entity. The Purchasing Entity pays actual shipping/freight costs from such port to the final destination and Contractor must include a freight cost invoice from the carrier for this cost to be submitted. This cost must be listed on the contractor's invoice as a separate line item. Contractor owns goods in transit to the final destination and is responsible for filing claims (if any).
- 4) Non-Appropriation of Funds: The Contractor acknowledges that the Purchasing Entity cannot contract for the payment of funds not yet appropriated. If funding is reduced due to an order by the Legislature or the Governor, or is required by State law, or if federal funding Page 3 of 6

(when applicable) is not provided for a subsequent fiscal year, the Participating Entity may terminate this PA or proportionately reduce the services and purchase obligations from the State at the end of the then current fiscal year upon thirty (30) days written notice. In the case that funds are not appropriated for a subsequent fiscal year or are reduced for a subsequent fiscal year, Purchasing Entities will reimburse Contractor for products in production, in transit, or delivered, and for services performed through the date of cancellation or reduction, and Purchasing Entities will not be liable for any future commitments, penalties, or liquidated damages.

- 6. <u>Subcontractors</u>: All contactors, dealers, and resellers authorized in the State of Alaska, as shown on the dedicated Contractor (cooperative contract) website, are approved to provide sales and service support to participants in the NASPO ValuePoint Master Agreement. The contractor's dealer participation will be in accordance with the terms and conditions set forth in the aforementioned Master Agreement.
- 7. Orders: Unless the parties to the order agree in writing that another contract or agreement applies to such order, any order placed by a Purchasing Entity for a product and/or service available from the Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions of) the Master Agreement as conditioned by this PA.
- 8. <u>Term</u>: This PA shall become effective as of the date of the last signature below and shall terminate upon the expiration or termination of the Master Agreement, as may be amended, unless the PA is terminated sooner in accordance with the terms set forth herein.
- 9. Amendment: Except as otherwise may be provided in this PA, amendments to the Master Agreement (including but not limited to extensions, renewals, and modifications to the terms, conditions, and pricing) will automatically be incorporated into this PA without the need to formally amend this PA.
