New Premium Services Pricing Option

Advanced Technologies Group, LLC (ATG) is excited to announce the expansion of the self-funding tablet program currently on the Master NASPO ValuePoint contract. The program enables agencies to get tablets for all inmates without spending any funds on tablets, network infrastructure or software.

Deployment of a tablet program requires:

- Centralized servers to provide program management, enforce security and host content
- Dedicated Local Area Network infrastructure at each institution to support tablets
- Wide Area Network from institution to ATG data center hosting the central servers
- Server and Firewall at each institution to cache content, enforce network security
- Secure tablets specifically designed for correctional institution deployment

ATG's program provides the agency of all of the above at no cost, including a tablet for each incarcerated person (user). The program includes free access the following services:

- Account Information
- Agency documents and videos
- Messaging to agency staff
- Grievance Program
- Khan Academy videos
- Guttenberg Project eBooks

User can choose to procure premium services (prices as listed in the master contract), such as

- Monthly subscription
 - Music: access to catalog of non-explicit music, concurrently have up to 500 songs downloaded to the tablet so they can be listened to without needing Wi-Fi offline, ability to create custom playlists, etc.
 - News: access curated list of agency-approved news websites
 - Podcasts: access a curated list of agency-approved podcasts
- Per-use services
 - Send message to friend/family for a flat fee
 - o Rent a movie

The program now offers an <u>additional</u> option. Agency can choose to offer users either:

- Current option of monthly subscriptions for premium services and per-use services as priced in the master contract
- New option of allowing users to purchase blocks of time for a flat fee that gives the user access to all premium services without incurring separate fees for each service used:
 - 60-minute block for \$ 1.50
 - 120-minute block for \$ 2.80
 - 180-minute block for \$ 4.00
 - 300-minute block for \$ 6.00

Users are only charged for the minutes used while logged into premium service session; they continue to have access to free services without using their purchased block of time. User has to use up the block of minutes within 30 days of its purchase.
