AMENDMENT NO. 1 TO NASPO VALUE POINT CONTRACT NO. ~~BPM-003137~~ CTR-058809, SWIFT CONTRACT NO. 213073, RELEASE NO. M-499(5)

THIS AMENDMENT is by and between the State of Minnesota, acting through its commissioner of Administration ("State"), and Quadient, Inc. USA, Inc., 478 Wheelers Farms Road, Milford, CT 06461 ("Contract Vendor").

WHEREAS, the State has a Contract with the Contract Vendor identified as Contract No. BPM-003137, SWIFT Contract No. 213073, January 1, 2023, through May 14, 2024 ("Contract"), to provide Mailroom Equipment, Supplies; and Maintenance Statewide; and


