BOTH PARTIES AGREE TO AMEND THE CONTRACT AS FOLLOWS:

New contract was BID and submitted in April of 2022, since April KI has had a list price increase effective on October 3, 2022. Similar to other furniture manufacturers (and, for that matter, virtually every other business and institution these days), KI continues to incur unprecedented cost increases across its entire supply chain. While we continue to absorb much of these increases, KI simply cannot absorb all and continue to offer competitive and superior quality products. KI will not compromise on that standard.

As a result, effective October 3, 2022, KI adjusted list prices for those individual product groups most affected by continuing cost increases. KI is requesting to start off the new contract at KI's current list price, all other terms and conditions will stay as negotiated, including discounts.
